

SENATE BILL No. 662

May 27, 1993, Introduced by Senators DUNASKISS, DI NELLO, CARL, GOUGEON and CISKY and referred to the Committee on Finance.

A bill to amend sections 520 and 522 of Act No. 281 of the Public Acts of 1967, entitled "Income tax act of 1967," section 520 as amended by Act No. 293 of the Public Acts of 1992

and section 522 as amended by Act No. 254 of the Public Acts of 1992 and section 522 as amended by Act No. 254 of the Public Acts of 1987, being sections 206.520 and 206.522 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Sections 520 and 522 of Act No. 281 of the
- 2 Public Acts of 1967, section 520 as amended by Act No. 293 of the
- 3 Public Acts of 1992 and section 522 as amended by Act No. 254 of
- 4 the Public Acts of 1987, being sections 206.520 and 206.522 of
- 5 the Michigan Compiled Laws, are amended to read as follows:
- Sec. 520. (1) Subject to the limitations and the
- 7 definitions set out in this chapter, a claimant may claim against

- 1 his or her state income tax otherwise due for the tax year a
- 2 credit for the property taxes on the homestead deductible for
- 3 federal income taxes pursuant to section 164 of the internal rev-
- 4 enue code, or that would have been deductible if the claimant had
- 5 not elected the zero bracket amount or if the claimant had been
- 6 subject to the federal income tax. The property taxes used for
- 7 the credit computation shall not be greater than the amount
- 8 levied for 1 tax year.
- 9 (2) A person who is renting or leasing a homestead may claim
- 10 a similar credit, computed pursuant to section 522, that shall be
- 11 based upon 17% of the gross rent paid. A person renting or leas-
- 12 ing a homestead subject to a service charge in lieu of ad valorem
- 13 taxes as provided by section 15a of the state housing development
- 14 authority act of 1966, Act No. 346 of the Public Acts of 1966, as
- 15 amended, being section 125.1415a of the Michigan Compiled Laws,
- 16 may claim a similar credit, computed pursuant to section 522,
- 17 that shall be based upon 10% of the gross rent paid.
- (3) If the allowable amount of the credit claimed under this
- 19 section exceeds the state income tax otherwise due for the tax
- 20 year or if there is no state income tax due for the tax year, the
- 21 amount of the claim not used as an offset against the state
- 22 income tax shall, after examination and review, be approved for
- 23 payment, without interest, to the claimant. A payment approved
- 24 pursuant to this subsection to a claimant eligible for a credit
- 25 under subsection (1) shall be made in a check or warrant exclu-
- 26 sive of refunds due for withholdings or other credits allowed by
- 27 this act. In determining the amount of this check or warrant,

- withholdings and other credits shall be used first to offset any
 tax liabilities.
- 3 (4) If the homestead is an integral part of a multipurpose
- 4 or multidwelling building that is federally aided housing or
- 5 state aided housing, a claimant who is a senior citizen entitled
- 6 to a payment under subsection (2) may assign the right to that
- 7 payment to a mortgagor who reduces the rent charged and collected
- s on the claimant's homestead in an amount equal to the tax credit
- 9 payment provided in this chapter. The assignment of the claim
- 10 shall be valid only if the Michigan state housing development
- 11 authority, by affidavit, verifies that the claimant's rent has
- 12 been so reduced.
- (5) Only the renter or lessee shall claim a credit on prop-
- 14 erty that is rented or leased as a homestead.
- 15 (6) A person who discriminates in the charging or collection
- 16 of rent on a homestead by increasing the rent charged or col-
- 17 lected because the renter or lessee is claiming and receiving a
- 18 credit or payment under this chapter is quilty of a misdemeanor.
- 19 Discrimination against a renter claiming and receiving the credit
- 20 by reduction of rent on the homestead of a person not claiming or
- 21 receiving the credit is a misdemeanor. If discriminatory rents
- 22 are charged or collected, each charge and collection of both the
- 23 higher and lower payment is a separate offense. Each acceptance
- 24 of a payment of rent is a separate offense.
- (7) A person who received aid to families with dependent
- 26 children, state family assistance, or state disability assistance
- 27 pursuant to the social welfare act, Act No. 280 of the Public

- 1 Acts of 1939, as amended, being sections 400.1 to 400.119b of
- 2 the Michigan Compiled Laws, in the tax year for which the person
- 3 is filing a return shall have a credit that is authorized pursu-
- 4 ant to this section and computed pursuant to section 522 reduced
- 5 by an amount equal to the product of the claimant's credit, as
- 6 computed pursuant to section 522, multiplied by the quotient of
- 7 the sum of the claimant's aid to families with dependent chil-
- 8 dren, state family assistance, and state disability assistance
- 9 for the tax year divided by the claimant's household income. The
- 10 reduction of credit shall not exceed the sum of the aid to fami-
- 11 lies with dependent children, state family assistance, and state
- 12 disability assistance for the tax year. For the purposes of this
- 13 subsection, aid to families with dependent children does not
- 14 include child support payments that offset or reduce payments
- 15 made to the claimant. This subsection applies only to the 1980
- 16 through the 1994 tax years.
- 17 (8) For tax years commencing after December 31, 1984, a
- 18 credit under subsection (1) or (2) shall be reduced by 10% for
- 19 each claimant whose household income exceeds \$73,650.00 and by an
- 20 additional 10% for each increment of \$1,000.00 of household
- 21 income in excess of \$73,650.00.
- 22 (9) If the credit permitted by subsection (2), that is cal-
- 23 culated pursuant to section 522 and adjusted pursuant to subsec-
- 24 tion (7) or (8), does not provide to a senior citizen who is
- 25 renting or leasing a homestead that amount attributable to rent
- 26 that constitutes more than the following percentage of the
- 27 household income of the senior citizen, the senior citizen may

- 1 claim a credit based upon the amount of household income
- 2 attributable to rent as provided by this section, subject to the
- 3 limitations of this section:
- (a) 50% for a credit claimed for the 1982 tax year.
- 5 (b) 45% for a credit claimed for the 1983 tax year.
- 6 (c) 40% for a credit claimed for the 1984 tax year or a tax 7 year after the 1984 tax year.
- g (10) For tax years commencing after December 31, 1981, a
- 9 senior citizen whose gross rent paid for the tax year is more
- 10 than the percentage of household income specified in subsection
- 11 (9) for the respective tax year may claim a credit for the amount
- 12 of rent paid that constitutes more than the percentage of the
- 13 household income of the senior citizen specified in subsection
- 14 (9) for the respective tax year and that was not provided to the
- 15 senior citizen by the credit computed pursuant to section 522 and
- 16 adjusted pursuant to subsection (7) or (8).
- 17 (11) The department may promulgate rules to implement sub-
- 18 sections (9) to (16) and may prescribe a table to allow a claim-
- 19 ant to determine the credit provided under subsections (9) to
- 20 (16) and section 522 in the instruction booklet that accompanies
- 21 the respective income tax or property tax credit forms used by
- 22 claimants.
- 23 (12) A senior citizen may claim the credit under subsections
- 24 (9) to (16) on the same form as the property tax credit permitted
- 25 by subsection (2). The department shall adjust the forms
- 26 accordingly.

- 1 (13) A senior citizen who, after December 31, 1981, moves to
- 2 a different rented or leased homestead shall determine, for 2 tax
- 3 years after the move, both his or her qualification to claim a
- 4 credit under subsections (9) to (16) and the amount of a credit
- 5 under subsections (9) to (16) on the basis of the annualized
- 6 final monthly rental payment at his or her previous homestead, if
- 7 this annualized rental is less than the senior citizen's actual
- 8 annual rental payments.
- 9 (14) For a return of less than 12 months, the claim for a
- 10 credit under subsections (9) to (16) shall be reduced
- 11 proportionately.
- 12 (15) The Michigan state housing development authority shall
- 13 report on the effect of the credit provided by subsections (9) to
- 14 (16) on the price of rented and leased homesteads. If the
- 15 authority determines that the price of rented and leased home-
- 16 steads has increased as a result of the credit provided by sub-
- 17 sections (9) to (16), the authority shall make recommendations to
- 18 the legislature to remedy this situation. The report shall be
- 19 made to the chairpersons of the house and senate committees that
- 20 have primary responsibility for taxation legislation 2 years
- 21 after the credit provided by subsections (9) to (16) is in
- 22 effect.
- 23 (16) The total credit allowed by -subsections (9) to (15)
- 24 THIS SECTION and section 522 shall not exceed \$1,200.00 -per
- 25 year FOR A TAX YEAR BEGINNING BEFORE 1993 AND \$1,400.00 FOR THE
- 26 1993 TAX YEAR. FOR EACH TAX YEAR AFTER 1993, THE MAXIMUM TOTAL

- 1 CREDIT PRESCRIBED BY THIS SUBSECTION EQUALS THE AMOUNT ARRIVED AT
- 2 AFTER PERFORMING THE FOLLOWING CALCULATIONS:
- 3 (A) MULTIPLY THE MAXIMUM CREDIT AMOUNT FOR THE IMMEDIATELY
- 4 PRECEDING TAX YEAR BY THE PERCENTAGE BY WHICH THE AVERAGE STATE-
- 5 WIDE CONSUMER PRICE INDEX FOR THE 12 MONTHS ENDING JULY 31 OF THE
- 6 TAX YEAR FOR WHICH THE CREDIT IS CLAIMED EXCEEDS THE AVERAGE
- 7 STATEWIDE CONSUMER PRICE INDEX FOR THE 12 MONTHS ENDING ON JULY
- 8 31 OF THE IMMEDIATELY PRECEDING TAX YEAR.
- 9 (B) ADD THE PRODUCT FROM SUBDIVISION (A) TO THE MAXIMUM
- 10 CREDIT AMOUNT FOR THE IMMEDIATELY PRECEDING TAX YEAR AND ROUND
- 11 THE RESULT TO THE NEAREST WHOLE DOLLAR.
- 12 (C) IF THE RESULT FROM SUBDIVISION (B) IS LESS THAN
- 13 \$2,500.00, ADD \$100.00 OR THE DIFFERENCE BETWEEN THE RESULT FROM
- 14 SUBDIVISION (B) AND \$2,500.00, WHICHEVER IS LESS, TO THE MAXIMUM
- 15 CREDIT AMOUNT FOR THE IMMEDIATELY PRECEDING TAX YEAR.
- 16 (17) Subsection (8) does not apply for any tax year to which
- 17 subsection (7) does not apply.
- 18 (18) AS USED IN THIS SECTION, "AVERAGE STATEWIDE CONSUMER
- 19 PRICE INDEX" MEANS THE MOST COMPREHENSIVE INDEX OF CONSUMER
- 20 PRICES AVAILABLE FOR THIS STATE FROM THE UNITED STATES DEPARTMENT
- 21 OF LABOR, BUREAU OF LABOR STATISTICS.
- 22 Sec. 522. (1) The amount of a claim made pursuant to this
- 23 chapter shall be determined as follows:
- 24 (a) A claimant -, other than a senior citizen, a paraplegic
- 25 or quadriplegic, a totally and permanently disabled person, an
- 26 eligible serviceperson, an eligible veteran, an eligible widow or
- 27 widower, or a blind person, is entitled to a credit against the

- 1 state income tax liability equal to 60% of the amount by which
- 2 the property taxes on the homestead, or the credit for rental of
- 3 the homestead for the taxable year, exceeds 3.5% of the
- 4 claimant's -total- household income for that taxable year.
- 5 (b) A CLAIMANT WHO IS A senior citizen or a paraplegic or
- 6 quadriplegic is entitled to a credit against the state income tax
- 7 liability for the amount by which the property taxes on the home-
- 8 stead, the credit for rental of the homestead, or a service
- 9 charge in lieu of ad valorem taxes as provided by section 15a of
- 10 the state housing development authority act of 1966, Act No. 346
- 11 of the Public Acts of 1966, as amended, being section 125.1415a
- 12 of the Michigan Compiled Laws, for the taxable year exceeds the
- 13 percentage of the claimant's -total- household income for that
- 14 taxable year computed as follows:

16	Not over \$3,000.00	.0%
17	Over \$3,000.00 but not over \$4,000.00	1.0%
18	Over \$4,000.00 but not over \$5,000.00	2.0%
19	Over \$5,000.00 but not over \$6,000.00	3.0%
20	Over \$6,000.00	3.5%

- 21 (c) A CLAIMANT WHO IS totally and permanently disabled
- 22 -person- is entitled to a credit against the state income tax
- 23 liability equal to 60% of the amount by which the property taxes
- 24 on the homestead, or the credit for rental of the homestead or
- 25 for a service charge in lieu of ad valorem taxes as provided in
- 26 section 15a of the state housing development authority act of

- 1 1966, -being section 125.1415a of the Michigan Compiled Laws ACT
- 2 NO. 346 OF THE PUBLIC ACTS OF 1966, for the taxable year, exceeds
- 3 the percentage of the claimant's -total- household income for
- 4 that taxable year based on the schedule in subdivision (b).
- 5 (d) An A CLAIMANT WHO IS AN eligible serviceperson, eligi-
- 6 ble veteran, or eligible widow or widower is entitled to a credit
- 7 against the state income tax liability for a percentage of the
- 8 property taxes on the homestead for the taxable year not in
- excess of 100% determined as follows:
- 10 (i) Divide the state equalized value allowance specified in
- 11 section 506 by the state equalized value of the homestead or, if
- 12 the eligible serviceperson, eligible veteran, or eligible widow
- 13 or widower leases or rents a homestead, divide 17% of the total
- 14 annual rent paid on the property by the property tax rate on the
- 15 property.
- 16 (ii) Multiply the property taxes on the homestead by the
- 17 percentage computed in subparagraph (i).
- (e) A claimant who is blind is entitled to a credit against
- 19 the state income tax liability for a percentage of the property
- 20 taxes on the homestead for the taxable year determined as
- 21 follows:
- 22 (i) If the state equalized value of the homestead is
- 23 \$3,500.00 or less, —— 100% of the property taxes.
- (ii) If the state equalized value of the homestead is more
- 25 than \$3,500.00, the percentage that \$3,500.00 bears to the state
- 26 equalized value of the homestead.

- 1 (2) A person who is qualified to make a claim -in UNDER
- 2 more than 1 -capacity CLASSIFICATION shall elect the -capacity
- 3 in CLASSIFICATION UNDER which the claim is made.
- 4 (3) Only 1 claimant per household for a tax year is entitled
- 5 to the credit, unless both the husband and wife filing a joint
- 6 return are blind, then each shall be considered a claimant.
- 7 (4) As used in this section, "totally and permanently
- 8 disabled" means disability as defined in section 216 of title II
- 9 of the social security act, CHAPTER 531, 49 STAT. 620, 42 U.S.C.
- **10** 416.
- 11 (5) A senior citizen who has a total household income for
- 12 the taxable year of \$6,000.00 or less and who for 1973 received a
- 13 senior citizen homestead exemption under former section 7c of THE
- 14 GENERAL PROPERTY TAX ACT, Act No. 206 of the Public Acts of 1893,
- 15 may compute the credit against the state income tax liability for
- 16 a percentage of the property taxes on the homestead for the tax-
- 17 able year determined as follows:
- 18 (a) If the state equalized value of the homestead is
- 19 \$2,500.00 or less, —— 100% of the property taxes.
- 20 (b) If the state equalized value of the homestead is more
- 21 than \$2,500.00, the percentage that \$2,500.00 bears to the state
- 22 equalized value of the homestead.
- 23 (6) For a return of less than 12 months, the claim shall be
- 24 reduced proportionately.
- 25 (7) The commissioner may prescribe tables that may be used
- 26 to determine the amount of the claim.

- 1 (8) The total credit allowed in this section —for a taxable

 2 period prior to January 1, 1976, shall not exceed \$500.00 per

 3 year and for each year after December 31, 1975, shall not exceed

 4 \$1,200.00 per year THE AMOUNT DETERMINED PURSUANT TO SECTION

 5 520(16).
- (9) The total credit allowable under this act and the farm7 land and open space preservation act, Act No. 116 of the Public
 8 Acts of 1974, as amended, being sections 554.701 to 554.719 of
 9 the Michigan Compiled Laws, shall not exceed the total property
 10 tax due and payable by the claimant in that year. The amount BY
 11 WHICH the credit exceeds the property tax due and payable shall
 12 be deducted from the credit claimed under THE FARMLAND AND OPEN
 13 SPACE PRESERVATION ACT, Act No. 116 of the Public Acts of 1974,
 14 as amended.
