

SENATE BILL No. 665

June 1, 1993, Introduced by Senators PRIDNIA, KOIVISTO and MC MANUS and referred to the Committee on Transportation and Tourism.

A bill to amend section 803m of Act No. 300 of the Public Acts of 1949, entitled as amended

"Michigan vehicle code,"

as added by Act No. 111 of the Public Acts of 1989, being section 257.803m of the Michigan Compiled Laws; and to add section 811c.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Section 803m of Act No. 300 of the Public Acts
- 2 of 1949, as added by Act No. 111 of the Public Acts of 1989,
- 3 being section 257.803m of the Michigan Compiled Laws, is amended
- 4 and section 811c is added to read as follows:
- 5 Sec. 803m. (1) The secretary of state may issue 2 special
- 6 organization motor vehicle registration plates to an applicant
- 7 for use on a passenger motor vehicle, pickup truck, van, or motor

8 home for which the plates are issued instead of standard plates.

- 1 A special organization motor vehicle registration plate is a
- 2 registration plate issued by the secretary of state that bears on
- 3 its face the symbol or emblem of an organization.
- 4 (2) Special organization plates shall bear letters and num-
- 5 bers as the secretary of state prescribes. Special organization
- 6 plates may contain the symbol of the organization to the left of
- 7 the plate number. The secretary of state shall not issue a
- 8 letter combination or permit the use of a symbol which might
- 9 carry a connotation offensive to good taste and decency. The
- 10 special organization plates shall be made of the same material as
- 11 standard plates. Special organization plates shall not be a
- 12 duplication of another registration plate.
- 13 (3) In order to qualify its members to receive special orga-
- 14 nization plates, an organization shall meet all of the following
- 15 criteria:
- (a) Be a nonprofit fraternal or public service
- 17 organization.
- 18 (b) Certify that it consists of not less than 500 members
- 19 and that not less than 500 members will apply for special organi-
- 20 zation registration plates.
- (c) Have a recognizable state, national, or international
- 22 symbol or emblem of the organization.
- 23 (d) Submit a service fee of \$500.00 for the initial manufac-
- 24 ture of the symbols or emblems for the special registration
- 25 plates.
- (e) Not practice or influence others to practice any form of
- 27 discrimination prohibited by the Elliott-Larsen civil rights act,

- 1 Act No. 453 of the Public Acts of 1976, being sections 37.2101 to 2 37.2804 of the Michigan Compiled Laws.
- 3 (4) If an organization meets the criteria set forth in sub-
- 4 section (3), the organization may request the secretary of state
- 5 to manufacture special organization registration plates for its
- 6 members. A request shall be accompanied by all of the
- 7 following:
- (a) A copy of the organization's charter and bylaws, ifany.
- 10 (b) A statement of the organization's consent to use of the
- 11 organization's symbol or emblem on special organization plates.
- 12 The statement shall be signed by the president or chief executive
- 13 officer of the organization.
- (c) A sample of the organization's symbol or emblem.
- 15 (d) The name of the organization's representative who will
- 16 serve as a contact person with the secretary of state.
- 17 (5) A member of an organization which has met the criteria
- 18 set forth in subsection (3) shall individually make application
- 19 for a special organization plate and submit with the application
- 20 the organization's confirmation of membership on a form provided
- 21 by the secretary of state.
- 22 (6) An application for a special organization registration
- 23 plate shall be submitted to the secretary of state pursuant to
- 24 the procedures prescribed in section 217. In addition to the
- 25 regular registration fee, each application for a new special
- 26 organization plate shall be accompanied by a service fee of
- 27 \$25.00. The service fee prescribed in this subsection shall not

- 1 be charged in connection with an application for a renewal tab
- 2 for an existing special organization plate. A special organi-
- 3 zation registration plate shall expire as provided in section
- 4 226.
- 5 (7) Each service fee collected under this section shall be
- 6 deposited in the state treasury and shall be credited to the
- 7 Michigan transportation fund. After deducting manufacturing and
- 8 administrative costs, the service fees shall be allocated pursu-
- 9 ant to section 10 of Act No. 51 of the Public Acts of 1951, being
- 10 section 247.660 of the Michigan Compiled Laws.
- 11 (8) The secretary of state may issue a temporary registra-
- 12 tion permit to a person who submits an application and the proper
- 13 fees for a special organization plate, if the applicant's current
- 14 vehicle registration will expire before his or her receipt of an
- 15 organization plate. The temporary registration shall expire upon
- 16 the applicant's receipt of an organization plate or upon the
- 17 expiration of 60 days after the date of issuance, whichever
- 18 occurs first. A temporary permit issued under this subsection
- 19 shall be issued without charge.
- 20 (9) THIS SECTION SHALL APPLY TO AN ORGANIZATION DESCRIBED IN
- 21 SECTION 811C ONLY TO THE EXTENT PROVIDED BY SECTION 811C.
- 22 SEC. 811C. (1) THE SECRETARY OF STATE SHALL DEVELOP AN
- 23 OLYMPIC EDUCATION-TRAINING CENTER REGISTRATION PLATE FOR EACH
- 24 CENTER IN THIS STATE AND, UPON APPLICATION, SHALL ISSUE SUCH A
- 25 PLATE TO AN APPLICANT FOR USE ON THE PASSENGER MOTOR VEHICLE,
- 26 PICKUP TRUCK, VAN, OR MOTOR HOME FOR WHICH THE PLATE IS ISSUED
- 27 INSTEAD OF A STANDARD REGISTRATION PLATE.

- 1 (2) AN APPLICATION FOR AN OLYMPIC EDUCATION-TRAINING CENTER
- 2 REGISTRATION PLATE SHALL BE SUBMITTED TO THE SECRETARY OF STATE
- 3 PURSUANT TO THE PROCEDURES PRESCRIBED IN SECTION 217. IN ADDI-
- 4 TION TO THE REGULAR REGISTRATION TAX IMPOSED BY SECTION 801, EACH
- 5 APPLICATION SHALL BE ACCOMPANIED WITH PAYMENT OF A SERVICE FEE OF
- 6 \$5.00 FOR THE FIRST MONTH AND \$3.00 PER MONTH FOR EACH ADDITIONAL
- 7 MONTH OF THE REGISTRATION PERIOD OF THE PLATE. OLYMPIC
- 8 EDUCATION-TRAINING CENTER REGISTRATION PLATES SHALL EXPIRE ON THE
- 9 APPLICANT'S BIRTHDAY PURSUANT TO SECTION 226.
- 10 (3) THE OLYMPIC EDUCATION-TRAINING CENTER FUND IS CREATED IN
- 11 THE STATE TREASURY. MONEY IN THE FUND SHALL BE EXPENDED ONLY AS
- 12 PROVIDED IN THIS SECTION.
- 13 (4) THE SECRETARY OF STATE SHALL DEPOSIT EACH SERVICE FEE
- 14 COLLECTED PURSUANT TO THIS SECTION WITH THE STATE TREASURER, TO
- 15 THE CREDIT OF THE OLYMPIC EDUCATION-TRAINING CENTER FUND. THE
- 16 FUND MAY RECEIVE MONEY FROM ANY OTHER SOURCE AS APPROPRIATED BY
- 17 THE LEGISLATURE. THE MONEY IN THE FUND SHALL, UPON APPROPRIA-
- 18 TION, BE DISTRIBUTED TO THE OLYMPIC EDUCATION-TRAINING CENTER
- 19 AFTER DEDUCTING MANUFACTURING AND ADMINISTRATIVE COSTS.
- 20 (5) THE OLYMPIC EDUCATION-TRAINING CENTER SHALL SUBMIT TO
- 21 THE SECRETARY OF STATE A DESIGN OF A SEPARATE DECAL TO BE AFFIXED
- 22 TO AN OLYMPIC EDUCATION-TRAINING CENTER REGISTRATION PLATE.
- 23 OLYMPIC EDUCATION-TRAINING CENTER REGISTRATION PLATES SHALL BE OF
- 24 THE SAME MATERIAL AS STANDARD REGISTRATION PLATES AND THE WORD
- 25 "MICHIGAN" SHALL BE STAMPED ACROSS THE TOP OF THE PLATE. OLYMPIC
- 26 EDUCATION-TRAINING CENTER REGISTRATION PLATES SHALL NOT BE A
- 27 DUPLICATION OF ANOTHER REGISTRATION PLATE. THE OLYMPIC

- 1 EDUCATION-TRAINING CENTER SHALL COMPLY WITH SECTION 803M(2),
- 2 (3)(C) AND (D), AND (4)(C) AND (D).
- 3 (6) THE SECRETARY OF STATE MAY ISSUE A TEMPORARY REGISTRA-
- 4 TION PERMIT TO A PERSON WHO SUBMITS AN APPLICATION AND THE PROPER
- 5 PAYMENTS FOR AN OLYMPIC EDUCATION-TRAINING CENTER REGISTRATION
- 6 PLATE, IF THE APPLICANT'S CURRENT VEHICLE REGISTRATION WILL
- 7 EXPIRE BEFORE HIS OR HER RECEIPT OF AN OLYMPIC EDUCATION-TRAINING
- 8 CENTER REGISTRATION PLATE. THE TEMPORARY REGISTRATION SHALL
- 9 EXPIRE UPON RECEIPT OF AN OLYMPIC EDUCATION-TRAINING CENTER REG-
- 10 ISTRATION PLATE OR 60 DAYS AFTER THE ISSUANCE, WHICHEVER OCCURS
- 11 FIRST. THE TEMPORARY PERMIT SHALL BE ISSUED WITHOUT A SEPARATE
- 12 FEE.
