

SENATE BILL No. 673

June 2, 1993, Introduced by Senator VAN REGENMORTER and referred to the Committee on Judiciary.

A bill to amend section 606 of Act No. 236 of the Public Acts of 1961, entitled as amended "Revised judicature act of 1961," as added by Act No. 52 of the Public Acts of 1988, being section 600.606 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Section 606 of Act No. 236 of the Public Acts of
- 2 1961, as added by Act No. 52 of the Public Acts of 1988, being
- 3 section 600.606 of the Michigan Compiled Laws, is amended to read
- 4 as follows:
- 5 Sec. 606. (1) The circuit court -shall have HAS jurisdic-
- 6 tion to hear and determine -a- 1 OR MORE OF THE FOLLOWING COMMIT-
- 7 TED BY A JUVENILE 15 YEARS OF AGE OR OLDER BUT LESS THAN 17 YEARS

- 1 (A) A violation of section 83, 89, 91, 316, 317, 520b, or
- 2 529 of the Michigan penal code, Act No. 328 of the Public Acts of
- 3 1931, being sections 750.83, 750.89, 750.91, 750.316, 750.317,
- 4 750.520b, and 750.529 of the Michigan Compiled Laws, or section
- 5 7401(2)(a)(i) or 7403(2)(a)(i) of the public health code, Act
- 6 No. 368 of the Public Acts of 1978, being sections 333.7401 and
- 7 333.7403 of the Michigan Compiled Laws. -, if committed by a
- 8 juvenile 15 years of age or older and less than 17 years of age.
- 9 (B) A VIOLATION OF A LAW OF THIS STATE PUNISHABLE BY IMPRIS-
- 10 ONMENT FOR MORE THAN 1 YEAR NOT DESCRIBED IN SUBSECTION (1) THAT
- 11 ARISES OUT OF THE SAME COURSE OF CONDUCT AS A VIOLATION DESCRIBED
- 12 IN SUBSECTION (1).
- 13 (2) IF A JUVENILE 15 YEARS OF AGE OR OLDER BUT LESS THAN 17
- 14 YEARS OF AGE IS BOUND OVER TO THE CIRCUIT COURT FOR FURTHER PRO-
- 15 CEEDINGS FOR A VIOLATION DESCRIBED IN SUBSECTION (1) (A) OR (B),
- 16 THE COURT HAS JURISDICTION OVER ANY LESSER INCLUDED OFFENSE OF
- 17 THE VIOLATION FOR WHICH THE JUVENILE IS CONVICTED AS THE RESULT
- 18 OF A TRIAL.
