

SENATE BILL No. 697

June 10, 1993, Introduced by Senators O'BRIEN, FAUST, VAUGHN and DE GROW and referred to the Committee on Education.

A bill to amend Act No. 328 of the Public Acts of 1931, entitled as amended
"The Michigan penal code,"

as amended, being sections 750.1 to 750.568 of the Michigan Compiled Laws, by adding section 472.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 328 of the Public Acts of 1931, as
- 2 amended, being sections 750.1 to 750.568 of the Michigan Compiled
- 3 Laws, is amended by adding section 472 to read as follows:
- 4 SEC. 472. (1) SUBJECT TO SUBSECTION (4), A PERSON SHALL NOT
- 5 POSSESS OR CONSUME AN ALCOHOLIC LIQUOR ON SCHOOL PROPERTY.
- 6 (2) A PERSON WHO VIOLATES SUBSECTION (1) IS GUILTY OF A MIS-
- 7 DEMEANOR, PUNISHABLE BY A FINE OF NOT MORE THAN \$50.00.
- 8 (3) AS USED IN THIS SECTION:

- 1 (A) "ALCOHOLIC LIQUOR" MEANS THAT TERM AS DEFINED IN SECTION
- 2 2 OF THE MICHIGAN LIQUOR CONTROL ACT, ACT NO. 8 OF THE PUBLIC
- 3 ACTS OF THE EXTRA SESSION OF 1933, BEING SECTION 436.2 OF THE
- 4 MICHIGAN COMPILED LAWS.
- 5 (B) "SCHOOL PROPERTY" MEANS A BUILDING, FACILITY, OR STRUC-
- 6 TURE AND OTHER REAL ESTATE OWNED, LEASED, OR OTHERWISE CONTROLLED
- 7 BY A PUBLIC SCHOOL OR PUBLIC SCHOOL SYSTEM IN WHICH 1 OR MORE OF
- 8 THE GRADES KINDERGARTEN TO 12 ARE TAUGHT.
- 9 (4) SUBSECTION (1) DOES NOT APPLY TO THE POSSESSION OR CON-
- 10 SUMPTION OF AN ALCOHOLIC LIQUOR DURING AN ACTIVITY LICENSED BY
- 11 THE LIOUOR CONTROL COMMISSION THAT OCCURS ON SCHOOL PROPERTY ON A
- 12 SATURDAY, SUNDAY, DAY ON WHICH NO REGULAR SCHOOL HOURS ARE SCHED-
- 13 ULED, OR AFTER 6 P.M. ON A DAY ON WHICH REGULAR SCHOOL HOURS ARE
- 14 SCHEDULED.
