



# SENATE BILL No. 758

July 20, 1993, Introduced by Senators SCHWARZ and GAST and referred to the Committee on Education.

A bill to amend section 2 of Act No. 156 of the Public Acts of 1967, entitled  
"Optional retirement act of 1967,"  
being section 38.382 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 2 of Act No. 156 of the Public Acts of  
2 1967, being section 38.382 of the Michigan Compiled Laws, is  
3 amended to read as follows:

4 Sec. 2. As used in this act:

5 (a) "Optional retirement program" means a system of retire-  
6 ment benefits established as a part of the plan of compensation  
7 for eligible teaching and administrative personnel.

8 (b) "Retirement system" means the Michigan public school  
9 employees' retirement system ~~provided for in chapter 1 of Act~~  
10 ~~No. 136 of the Public Acts of 1945, as amended, being sections~~

1 ~~38.201 to 38.234 of the Compiled Laws of 1948~~ CREATED BY THE  
2 PUBLIC SCHOOL EMPLOYEES RETIREMENT ACT OF 1979, ACT NO. 300 OF  
3 THE PUBLIC ACTS OF 1980, BEING SECTIONS 38.1301 TO 38.1408 OF THE  
4 MICHIGAN COMPILED LAWS.

5 (c) "Eligible employees" means the members of the faculty  
6 and administrative staff of state supported institutions of  
7 higher education on a full-time basis whose positions require the  
8 performance of professional services in the discharge of the edu-  
9 cational or administrative functions of the institution.

10 (d) "State supported ~~institutions~~ INSTITUTION of higher  
11 education" means ~~western~~ ANY OF THE FOLLOWING:

12 (i) WESTERN Michigan university. ~~, eastern~~

13 (ii) EASTERN Michigan university. ~~, northern~~

14 (iii) NORTHERN Michigan university. ~~, central~~

15 (iv) CENTRAL Michigan university. ~~,~~

16 (v) Michigan technological university. ~~and~~

17 (vi) Ferris state ~~college~~ UNIVERSITY.

18 (vii) A COMMUNITY OR JUNIOR COLLEGE ESTABLISHED PURSUANT TO  
19 SECTION 7 OF ARTICLE VIII OF THE STATE CONSTITUTION OF 1963.

20 (viii) A COMMUNITY OR JUNIOR COLLEGE ESTABLISHED PURSUANT TO  
21 PART 25 OF THE SCHOOL CODE OF 1976, ACT NO. 451 OF THE PUBLIC  
22 ACTS OF 1976, BEING SECTIONS 380.1601 TO 380.1607 OF THE MICHIGAN  
23 COMPILED LAWS.

24 (e) "~~Boards~~ BOARD of control" means the ~~boards~~ BOARD  
25 charged with policy direction of A state supported ~~institutions~~  
26 INSTITUTION of higher education.

1       Section 2. This amendatory act shall take effect on  
2 October 1, 1993.
