

## SENATE BILL No. 832

September 21, 1993, Introduced by Senator HOFFMAN and referred to the Commmittee on Family Law, Criminal Law, and Corrections.

A bill to amend Act No. 295 of the Public Acts of 1982, entitled as amended

"Support and visitation enforcement act," as amended, being sections 552.601 to 552.650 of the Michigan Compiled Laws, by adding section 26.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 295 of the Public Acts of 1982, as
- 2 amended, being sections 552.601 to 552.650 of the Michigan
- 3 Compiled Laws, is amended by adding section 26 to read as
- 4 follows:
- 5 SEC. 26. (1) THERE IS A LIEN AGAINST THE PAYER'S REAL AND
- 6 PERSONAL PROPERTY FOR THE CUMULATIVE AMOUNT OF PAYMENTS DUE UNDER
- 7 A SUPPORT ORDER, IF EACH OF THE PAYMENTS HAS BECOME A JUDGMENT
- 8 UNDER SECTION 3 AND IF EITHER OF THE FOLLOWING CONDITIONS ARE
- 9 MET:

- 1 (A) EACH PAYMENT HAS BEEN DUE FOR NOT LESS THAN 90 DAYS.
- 2 (B) THE CUMULATIVE AMOUNT OF PAYMENTS DUE EQUALS OR EXCEEDS 3 \$2,000.00.
- 4 (2) A PAYMENT THAT BECOMES A JUDGMENT UNDER SECTION 3 AFTER
- 5 THE INITIAL IMPOSITION OF A LIEN BY THIS SECTION IS ADDED TO THE
- 6 LIEN AMOUNT. THE OFFICE OF THE FRIEND OF THE COURT SHALL IMMEDT-
- 7 ATELY PROCEED WITH THE ENFORCEMENT OF A LIEN IMPOSED BY THIS
- 8 SECTION. A LIEN IMPOSED BY THIS SECTION IS ENFORCEABLE IN THE
- 9 SAME MANNER AS A LIEN IMPOSED BY THE COURT UNDER SECTION 25.
- 10 (3) THE OFFICE OF THE FRIEND OF THE COURT SHALL FILE A
- 11 NOTICE OF THE LIEN IMPOSED BY THIS SECTION WITH THE SECRETARY OF
- 12 STATE AND THE REGISTER OF DEEDS IN EACH COUNTY IN WHICH THE PAYER
- 13 HAS A PROPERTY INTEREST. THE NOTICE SHALL INCLUDE SUFFICIENT
- 14 INFORMATION TO IDENTIFY THE PAYER AND PROPERTY SO THAT THE SECRE-
- 15 TARY OF STATE OR REGISTER OF DEEDS MAY RECORD THE LIEN AGAINST
- 16 THE PROPERTY.
