"Public health code,"

being section 333 12521 of the Michigan Compiled Laws and to add section 12522a

THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- 1 Section 1 Section 12521 of Act No 368 of the Public Acts
- 2 of 1978 being section 333 12521 of the Michigan Compiled Laws,
- 3 is amended and section 12522a is added to read as follows
- 4 Sec 12521 As used in sections 12521 to 12534
- 5 (a) "Person" means a person as defined in section 1106 or a
- 6 governmental entity
- 7 (b) "Public swimming pool" means an artificial body of water
- 8 used collectively by a number of individuals primarily for the
- 9 purpose of swimming, wading, recreation, or instruction and

- 1 includes related equipment structures, areas, and enclosures
- 2 intended for the use of individuals using or operating the swim-
- 3 ming pool such as equipment, dressing, locker, shower, and toilet
- 4 rooms Public swimming -pools include those which are for parks,
- 5 schools, motels, camps, resorts, apartments, clubs, hotels,
- 6 mobile home parks, subdivisions, and the like POOL INCLUDES AN
- 7 ARTIFICIAL BODY OF WATER LOCATED IN OR OPERATED BY A PARK,
- 8 SCHOOL, MOTEL, CAMP, RESORT, APARTMENT, CLUB, HOTEL, MOBILE HOME
- 9 PARK, SUBDIVISION, OR SIMILAR ENTITY -A PUBLIC SWIMMING POOL
- 10 DOES NOT INCLUDE A pool or portable pool located on the -same-
- 11 premises —with—OF a 1-, 2-, 3-, or 4-family dwelling —and—for
- 12 the benefit of the DWELLING occupants and their guests, a natural
- 13 bathing area such as a stream, lake, river, or man-made lake, an
- 14 exhibitor's swimming pool built as a model at the site of the
- 15 seller -and- in which swimming by the public is not permitted, or
- 16 a pool serving not more than 4 motel units -is not a public
- 17 swimming pool-
- 18 (C) "STARTING PLATFORM" MEANS A DEVICE TEMPORARILY OR PER-
- 19 MANENTLY PLACED IN OR AT THE EDGE OF A PUBLIC SWIMMING POOL TO
- 20 PROVIDE A SURFACE FROM WHICH TO DIVE
- 21 SEC 12522A A PERSON SHALL NOT ERECT OR MAINTAIN A START-
- 22 ING PLATFORM IN OR AT THE EDGE OF A PUBLIC SWIMMING POOL IF WATER
- 23 IMMEDIATELY SURROUNDING THE STARTING PLATFORM IS LESS THAN 5 FEET
- 24 DEEP
