A bill to amend section 22229 of Act No 368 of the Public Acts of 1978, entitled as amended

"Public health code,"

THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- 3 being section 333 22229 of the Michigan Compiled Laws, is amended
- 4 to read as follows
- 5 Sec 22229 (1) The following proposed projects are subject
- 6 to comparative review
- 7 (a) Proposed projects specified as subject to comparative
- 8 review in a certificate of need review standard

- 1 (b) New beds in a health facility that is a hospital,
- 2 hospital long-term care unit, or nursing home if there are
- 3 multiple applications to meet the same need for projects that,
- 4 when combined, exceed the need of the planning area as determined
- 5 by the applicable certificate of need review standards
- 6 (2) Replacement beds in a hospital that are proposed for
- 7 construction on the original site, on a contiguous site, within a
- 8 5-mile radius of the original site if the hospital is located in
- 9 a county with a population of less than 200,000, or within a
- 10 2-mile radius of the original site if the hospital is located in
- 11 a county with a population of 200,000 or more, are not subject to
- 12 comparative review
- 13 (3) Replacement beds in a nursing home that is located in a
- 14 nonrural county that are proposed for construction on the origi-
- 15 nal site OR on a contiguous site or THAT ARE PROPOSED
- 16 FOR CONSTRUCTION within a -2-mile 5-MILE radius of the original
- 17 site WITHIN THE CORPORATE CITY BOUNDARIES OF A CITY BEING SERVED
- 18 BY THE BEDS BEING REPLACED AT THE TIME THE CERTIFICATE OF NEED
- 19 APPLICATION IS FILED, AND WITHIN THE PLANNING AREA BEING SERVED
- 20 BY THE BEDS BEING REPLACED AT THE TIME THE CERTIFICATE OF NEED
- 21 APPLICATION IS FILED are not subject to comparative review
- 22 Replacement beds in a nursing home that is located in a rural
- 23 county that are proposed for construction on the original site,
- 24 on a contiguous site, or within the same planning area are not
- 25 subject to comparative review
- 26 (4) The commission may approve certificate of need review
- 27 standards that establish comparative review or an alternative

- 1 procedure for determining whether 1 or more of several qualified
- 2 applicants may be approved if the level of need is not sufficient
- 3 to justify approval of all qualified applicants If an applicant
- 4 involves more than 1 health facility, the applicant shall indi-
- 5 cate on the application the proposed site or sites for the
- 6 project and arrangements for the utilization and financing of the
- 7 covered clinical services
