THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- Section 1 Act No 328 of the Public Acts of 1931, as
- 2 amended being sections 750 1 to 750 568 of the Michigan Compiled
- **3** Laws is amended by adding section 81b to read as follows
- 4 SEC 81B (1) A PERSON WHO ASSAULTS OR BATTERS A STATE OR
- 5 LOCAL CORRECTIONAL OFFICER PERFORMING HIS OR HER DUTIES AS A
- 6 STATE OR LOCAL CORRECTIONAL OFFICER OR BECAUSE OF HIS OR HER
- 7 EMPLOYMENT AS A STATE OR LOCAL CORRECTIONAL OFFICER IS GUILTY OF
- 8 A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 4 YEARS OR
- 9 A FINE OF NOT MORE THAN \$2,500 00, OR BOTH

- 1 (2) A TERM OF IMPRISONMENT IMPOSED FOR A VIOLATION OF THIS
- 2 SECTION SHALL BE SERVED CONSECUTIVELY TO ANY OTHER TERM OF
- 3 IMPRISONMENT TO WHICH THE PERSON IS SENTENCED
- 4 (3) AS USED IN THIS SECTION
- 5 (A) "CORRECTIONAL FACILITY" MEANS EITHER OF THE FOLLOWING
- 6 (1) A FACILITY OR INSTITUTION THAT HOUSES AN INMATE POPULA-
- 7 TION UNDER THE JURISDICTION OF THE DEPARTMENT OF CORRECTIONS
- 8 (11) A MUNICIPAL OR COUNTY JAIL, WORK CAMP, LOCKUP, HOLDING
- 9 CENTER, HALFWAY HOUSE, COMMUNITY CORRECTIONS CENTER OR ANY OTHER
- 10 FACILITY MAINTAINED BY A MUNICIPALITY OR COUNTY THAT HOUSES ADULT
- 11 PRISONERS
- 12 (B) "LOCAL CORRECTIONAL OFFICER" MEANS A PERSON EMPLOYED BY
- 13 A UNIT OF LOCAL GOVERNMENT IN A CORRECTIONAL FACILITY AS A COR-
- 14 RECTIONAL OFFICER
- 15 (C) "STATE CORRECTIONAL OFFICER" MEANS A PERSON EMPLOYED BY
- 16 THE DEPARTMENT OF CORRECTIONS IN A CORRECTIONAL FACILITY AS A
- 17 CORRECTIONAL OFFICER OR A CORRECTIONS MEDICAL AIDE
