

SENATE BILL No. 1085

April 12, 1994, Introduced by Senator DILLINGHAM and referred to the Committee on Transportation and Tourism

A bill to amend sections 19 25 31 49 52, 53 55, 57, and 59 of Act No 187 of the Public Acts of 1990, entitled
"The pupil transportation act,"
section 55 as amended by Act No 184 of the Public Acts of 1991, being sections 257 1819, 257 1825, 257 1831, 257 1849, 257 1852, 257 1853, 257 1855, 257 1857, and 257 1859 of the Michigan Compiled Laws to add sections 9a and 38 and to repeal certain parts of the act on a specific date

- 1 SEC 9A A LOCAL AUTHORITY SHALL NOT ADOPT, ENACT, OR
- 2 ENFORCE A STATUTE, CHARTER PROVISION, ORDINANCE, RULE, OR REGULA-
- 3 TION IN CONFLICT WITH THIS ACT
- 4 Sec 19 (1) A school bus shall be equipped with signal
- 5 lamps mounted as high and widely spaced laterally as practicable
- 6 which shall be capable of displaying to the front 2 alternately
- 7 flashing red lamps located at the same level and to the rear 2
- 8 alternately flashing red lamps located at the same level
- 9 (2) In addition to the 4 red lamps described in
- 10 subsection (1), 4 amber lamps shall be installed near each red
- 11 signal lamp, at the same level, but closer to the vertical center
- 12 line of the bus The system of red and amber signal lamps shall
- 13 be wired so that the amber lamps are energized manually, and the
- 14 red lamps are automatically energized, with the amber lamps being
- 15 automatically -de-energized DEACTIVATED, when the bus service
- 16 door is opened
- 17 (3) The area around the lens of each alternately flashing
- 18 signal lamp and extending outward approximately 3 inches shall be
- 19 painted black In installations where there is no flat vertical
- 20 portion of body immediately surrounding the entire lens of a
- 21 lamp, a circular or square band of black approximately 3 inches
- 22 wide, immediately below and to both sides of a lens, shall be
- 23 painted on the body or roof area against which the signal lamp is
- 24 seen from a distance of 500 feet along the axis of the vehicle
- 25 Visors or hoods with an appropriate black background to fit their
- 26 shape and roofcap may also be used These amber and red sealed
- 27 beam lights shall have sufficient intensity to be visible from a

- 1 distance of not less than 500 feet in normal sunlight Lamps
- 2 indicating alternately flashing light operation shall be visible
- 3 to the driver when in a normal seated position
- 4 (4) This section shall apply to new school buses manufac-
- 5 tured on or after October 1, 1990 and to school buses manufac-
- 6 tured before October 1, 1990 that are retrofitted to meet the
- 7 requirements of this section
- 8 Sec 25 (1) A school bus OR PUPIL TRANSPORTATION VEHICLE
- 9 shall be equipped with at least 1, 2A-10BC dry chemical fire
- 10 extinguisher, or its equivalent, that is approved by the depart-
- 11 ment of state police and that has an aluminum, brass, or bronze
- 12 valve The extinguisher shall be mounted securely in an accessi-
- 13 ble place in the driver's compartment and shall be in satisfac-
- 14 tory operating condition at all times
- 15 (2) A school bus or pupil transportation vehicle shall be
- 16 equipped with a first aid kit which shall be firmly mounted with
- 17 a quick release bracket in an accessible location in the driver's
- 18 compartment and which shall contain, at a minimum, all of the

- 6 TRANSPORTATION VEHICLE SHALL TAKE A DRIVER SKILLS TEST AS ESTAB-
- 7 LISHED BY THE DEPARTMENT OF EDUCATION AND THE SCHOOL BUS SAFETY
- 8 ADVISORY COMMITTEE CREATED UNDER SECTION 70 AND APPROVED BY THE

- 26 (3) A school shall submit transportation safety related
- 27 documents, such as driver qualification records and vehicle

- 4 (4) Upon receipt of an application from a person for the
- 5 position of school bus driver or pupil transportation vehicle

- 7 police a background check to determine whether the person was
- 8 convicted of any of the following offenses
- 9 (a) Criminal sexual conduct in any degree
- 10 (b) Assault with intent to commit criminal sexual conduct
- 11 (c) An attempt to commit criminal sexual conduct in any
- 12 degree
- (d) Felonious assault on a child child abuse, or cruelty,
- 14 torture, or indecent exposure involving a child
- (e) A violation of section 145c of the Michigan penal code,
- 16 Act No 328 of the Public Acts of 1931 being section 750 145c of
- 17 the Michigan Compiled Laws
- 18 (5) A person shall not smoke on a school bus -or pupil
- 19 transportation vehicle -within-1 hour before use of the school
- 20 bus or pupil transportation vehicle by pupils OR SCHOOL TRANS-
- 21 PORTATION VEHICLE
- 22 (6) A person shall not possess or consume alcoholic liquor
- 23 or a controlled substance on a school bus, -or pupil transporta-
- 24 tion vehicle, OR SCHOOL TRANSPORTATION VEHICLE
- 25 (7) THE SCHOOL ADMINISTRATOR OR PERSON OR ENTITY UNDER CON-
- 26 TRACT WITH A SCHOOL SHALL ESTABLISH A WRITTEN POLICY WHICH MAY
- 27 INCLUDE MONITORING OR TRAINING, OR BOTH, DESIGNED TO COVER THE

- 12 driver shall not actuate the alternately flashing lights when
- 13 operating on a public highway or private road and transporting
- 14 passengers primarily other than school pupils
- 15 (2) The driver of a school bus while operating upon the
- 16 public highways or private roadways open to the public shall
- 17 receive or discharge pupils from the bus in the following
- 18 manner
- (a) If pupils are required to cross the roadway the driver
- 20 of a school bus equipped with only the alternately flashing
- 21 OVERHEAD red lights in accordance with section 17 shall activate
- 22 the ALTERNATELY flashing OVERHEAD red lights not less than 200
- 23 feet before the stop, -and-park- STOP the school bus as far -off-
- 24 TO the right side of the -roadway- HIGHWAY or private road as
- 25 possible TO PROVIDE for the safety of the pupils being boarded or
- 26 discharged, and continue to activate the alternately flashing
- 27 OVERHEAD red lights while receiving or discharging pupils

- 1 Before resuming motion, the driver shall deactivate these lights
- 2 and allow congested traffic to disperse where practicable The
- 3 deactivation of these lights is the signal for stopped traffic to
- 4 proceed
- 5 (b) If the pupils are required to cross the roadway, the
- 6 driver of a school bus equipped with red and amber alternately
- 7 flashing OVERHEAD lights in accordance with section 19 shall
- 8 activate the alternately flashing OVERHEAD amber lights not less
- 9 than 200 feet before the stop, -park- STOP the bus as far -off-
- 10 TO the right side of the -roadway- HIGHWAY or private road as is
- 11 possible TO PROVIDE for the safety of the pupils being boarded or
- 12 discharged, deactivate the -amber ALTERNATELY flashing OVERHEAD
- 13 AMBER lights, and activate the alternately flashing OVERHEAD red
- 14 lights while receiving or discharging pupils Before resuming
- 15 motion, the driver shall deactivate these lights and allow con-
- 16 gested traffic to disperse where practicable The deactivation
- 17 of these lights is the signal for stopped traffic to proceed
- 18 (c) If the pupils are not required to cross the roadway and
- 19 where the road has adequate width for the school bus to be pulled
- 20 to the far right of the -roadway- HIGHWAY or private road allow-
- 21 ing traffic to flow and to provide for the safety of pupils being
- 22 boarded or discharged, the driver may activate the hazard warning
- 23 lights not less than 200 feet before the stop and continue to
- 24 display the lights until the process of receiving or discharging
- 25 passengers has been completed if the -posted LAWFUL speed limit
- 26 is 35 miles per hour or less Before resuming motion the driver
- 27 shall deactivate these lights The driver of a school bus shall

- 1 only use this procedure at stops where the school administrator
- 2 or -board approved contractor PERSON OR ENTITY UNDER CONTRACT
- 3 WITH A SCHOOL TO PROVIDE PUPIL TRANSPORTATION SERVICES has
- 4 approved its use If this hazard warning light option is not
- 5 used, the driver shall use the appropriate procedure in
- 6 subdivision (a) or (b) as if pupils were required to cross the
- 7 roadway
- 8 (d) Except as provided in subdivision (c), if the pupils are
- 9 not required to cross the roadway and where the bus may be pulled
- 10 off the roadway or private road or where the road has adequate
- 11 width for the school bus to be pulled off to the far right of the
- 12 -roadway HIGHWAY or private road leaving the normal traffic flow
- 13 unobstructed and to provide for the safety of pupils being
- 14 boarded or discharged, the driver may activate the hazard warning
- 15 lights not less than 200 feet before the stop and continue to
- 16 display the lights until the process of receiving or discharging
- 17 passengers has been completed Before resuming motion, the
- 18 driver shall deactivate these lights The driver of a school bus
- 19 shall only use this procedure at stops where the school adminis-
- 20 trator or -board approved contractor- PERSON OR ENTITY UNDER CON-
- 21 TRACT WITH A SCHOOL TO PROVIDE PUPIL TRANSPORTATION SERVICES has
- 22 approved its use If this hazard warning light option is not
- 23 used, the driver shall use the appropriate procedure in
- 24 subdivision (a) or (b) as if pupils were required to cross the
- 25 roadway
- (e) The distance of not less than 200 feet required for
- 27 light activation by this subsection shall be measured on the

- 1 roadway or private road on which the stop is made for receiving
- 2 or discharging pupils
- 3 (3) —Passengers— PUPILS crossing the road upon being dis-
- 4 charged from a school bus shall cross in front of the stopped
- 5 school bus If a school district authorizes its school bus driv-
- 6 ers to signal pupils to cross in front of the stopped school bus,
- 7 the signal shall be uniform throughout the school district
- 8 (4) The driver of a school bus shall not stop the bus for
- 9 the purpose of receiving or discharging pupils in the following
- 10 instances
- 11 (a) Within 200 feet of a public highway or roadway intersec-
- 12 tion unless the stop is approved by the school administrator or
- 13 -board approved contractor PERSON OR ENTITY UNDER CONTRACT WITH
- 14 A SCHOOL TO PROVIDE PUPIL TRANSPORTATION SERVICES
- (b) Upon a limited access highway or freeway or upon any
- 16 other highway or roadway that has been divided into 2 roadways by
- 17 leaving an intervening space a physical barrier, or clearly
- 18 divided sections so constructed as to impede vehicular traffic if
- 19 the pupils are required to cross the highway or roadway
- 20 (c) Upon a -highway or roadway constructed or -designed-
- 21 MARKED to permit 3 or more separate lanes of vehicular traffic in
- 22 either direction if the pupils are required to cross the highway
- 23 or roadway
- (5) The driver of a school bus when using the alternately
- 25 flashing OVERHEAD red -stopping- lights shall not stop the bus
- 26 for the purpose of receiving or discharging pupils in the
- 27 following instances

- 1 (a) Unless the bus is clearly and continuously visible in
- 2 its stopped position to approaching vehicles on that highway or
- 3 roadway for not less than 400 feet CLEAR AND CONTINUOUS VISI-
- 4 BILITY SHALL NOT BE REQUIRED WITHIN 400 FEET FROM THE END OF A
- 5 HIGHWAY OR ROADWAY ON WHICH THE STOP IS BEING MADE IF THERE IS
- 6 CLEAR AND CONTINUOUS VISIBILITY TO THE END OF THE HIGHWAY OR
- 7 ROADWAY THIS REQUIREMENT SHALL APPLY ON A ROADWAY WITH A LAWFUL
- 8 SPEED LIMIT OF MORE THAN 35 MILES PER HOUR
- 9 (B) UNLESS THE BUS IS CLEARLY AND CONTINUOUSLY VISIBLE IN
