THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- Section 1 Act No 451 of the Public Acts of 1976, as
- 2 amended, being sections 380 1 to 380 1852 of the Michigan
- 3 Compiled Laws, is amended by adding section 1166a to read as
- 4 follows
- 5 SEC 1166A (1) THE BOARD OF A SCHOOL DISTRICT OR LOCAL ACT
- 6 SCHOOL DISTRICT MAY ALLOW AND ENCOURAGE A TEACHER OR SCHOOL
- 7 ADMINISTRATOR EMPLOYED IN THE SCHOOL DISTRICT TO READ ALOUD OR TO
- 8 POST IN A SCHOOL BUILDING OR CLASSROOM OR AT A SCHOOL EVENT ALL
- 9 OR PART OF ANY OF THE FOLLOWING DOCUMENTS

- 17 (K) ANY ACT OF THE UNITED STATES CONGRESS
- 18 (1) THE PUBLISHED TEXT OF THE CONGRESSIONAL RECORD
- 19 (2) THE BOARD OF A SCHOOL DISTRICT OR LOCAL ACT SCHOOL DIS-
- 20 TRICT SHALL ENSURE THAT THERE IS NO CENSORSHIP OF THE CONTENT OF
- 21 ANY DOCUMENT DESCRIBED IN SUBSECTION (1) IN THE UNITED STATES
- 22 HISTORY OR HERITAGE CURRICULUM OR INSTRUCTION IN THE SCHOOL DIS-
- 23 TRICT BASED ON RELIGIOUS OR OTHER REFERENCES IN THE DOCUMENT
- 24 (3) NOT LATER THAN 60 DAYS AFTER THE EFFECTIVE DATE OF THIS
- 25 SECTION, THE SUPERINTENDENT OF PUBLIC INSTRUCTION SHALL PROVIDE
- 26 TO THE BOARD OF EACH SCHOOL DISTRICT OR LOCAL ACT SCHOOL DISTRICT
- 27 SUFFICIENT COPIES OF THIS SECTION FOR DISTRIBUTION TO EACH

- 1 TEACHER AND SCHOOL ADMINISTRATOR EMPLOYED BY THE SCHOOL
- 2 DISTRICT UPON RECEIPT OF THE COPIES, A SCHOOL BOARD SHALL DIS-
- 3 TRIBUTE A COPY OF THIS SECTION TO EACH OF ITS TEACHERS AND SCHOOL
- 4 ADMINISTRATORS
