

SENATE BILL No. 1152

May 12, 1994, Introduced by Senator DE GROW and referred to the Committee on Appropriations

A bill to amend section 6 of Act No 300 of the Public Acts of 1980, entitled

"The public school employees retirement act of 1979 "
as amended by Act No 318 of the Public Acts of 1993 being section 38 1306 of the Michigan Compiled Laws

THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- Section 1 Section 6 of Act No 300 of the Public Acts of
- 2 1980 as amended by Act No 318 of the Public Acts of 1993 being
- 3 section 38 1306 of the Michigan Compiled Laws, is amended to read
- 4 as follows
- 5 Sec 6 (1) "Original member" means a member employed in
- 6 Michigan public schools before July 1, 1945
- 7 (2) "Out of system public education service" means service
- 8 performed in public education meeting 1 or more of the following
- 9 requirements

- 1 (a) Performed in other states in the United States or its
 2 territorial possessions
- 3 (b) Performed at the university of Michigan Michigan state
- 4 university, Wayne state university, Grand Valley state universi-
- 5 ty, Oakland university, or Saginaw Valley university
- 6 (c) Service purchased before January 31 1991 and performed
- 7 in a juvenile training school operated by a county in this
- 8 state
- 9 (d) Service purchased before January 31, 1991 and performed
- 10 in a community mental health service program operated under
- 11 former Act No 54 of the Public Acts of 1963 for the severely
- 12 mentally retarded in day care programs, day training programs or
- 13 day care training programs that were transferred to an intermedi-
- 14 ate school district by direction of the department of education
- (e) Service purchased before January 31, 1991 and performed
- 16 as an elementary or secondary teacher at a United States armed
- 17 forces military base in the United States or a foreign country
- (f) Service purchased before January 31 1991 and performed
- 19 as a teacher or administrator of American nationals in overseas
- 20 public elementary or secondary schools operated by the United
- 21 States department of defense
- 22 (3) "Prior service" means service performed before July 1,
- 23 1945
- 24 (4) EXCEPT AS OTHERWISE PROVIDED IN THIS SUBSECTION, "PUBLIC
- 25 SCHOOL ACADEMY" MEANS A PUBLIC SCHOOL ACADEMY ESTABLISHED UNDER
- 26 PART 6A OF THE SCHOOL CODE OF 1976, ACT NO 451 OF THE PUBLIC
- 27 ACTS OF 1976, BEING SECTIONS 380 501 TO 380 507 OF THE MICHIGAN

- 1 COMPILED LAWS PUBLIC SCHOOL ACADEMY DOES NOT INCLUDE ANY OF THE
- 2 FOLLOWING
- 3 (A) A PUBLIC SCHOOL ACADEMY OPERATED BY A STATE PUBLIC UNI-
- 4 VERSITY NOT LISTED IN SUBSECTION (5)
- 5 (B) A PUBLIC SCHOOL ACADEMY CORPORATION FORMED BY A STATE
- 6 PUBLIC UNIVERSITY NOT LISTED IN SUBSECTION (5)
- 7 (5) -(4) "Public school employee" means an employee of a
- 8 public local school district, intermediate school district
- 9 public school academy, tax supported community or junior college
- 10 eastern Michigan university, central Michigan university, north-
- 11 ern Michigan university western Michigan university Ferris
- 12 state university, Michigan technological university, Lake
- 13 Superior state university, or district library as defined in
- 14 section 69g if the conditions in section 69g(1) are met for that
- 15 employee Service at Michigan technological university shall be
- 16 creditable only if the amount of the accumulated contributions in
- 17 the state employees' retirement system for service is paid to the
- 18 retirement system Service at Ferris state university shall be
- 19 creditable as prior service or membership service only if the
- 20 employee was employed at Ferris state university on a full-time
- 21 basis for 2 or more years after May 17, 1949 Until January 1
- 22 1988 public school employee also includes a person holding a
- 23 Michigan teacher certificate and serving as an employee of the
- 24 Michigan high school athletic association, other than a person
- 25 whose effective date of employment with the Michigan high school
- 26 athletic association is on or after December 31, 1986 A public

- 1 school employee on an approved leave of absence is included
- 2 within this definition
