

SENATE BILL No. 1198

June 22, 1994, Introduced by Senator HONIGMAN and referred to the Committee on Local Government and Urban Development

A bill to amend Act No 278 of the Public Acts of 1909, entitled as amended

"An act to provide for the incorporation of villages and for revising and amending their charters to provide for the levy and collection of taxes, borrowing of money, and issuance of bonds and other evidences of indebtedness and to validate bonds issued and obligations previously incurred,"

as amended, being sections 78 1 to 78 28 of the Michigan Compiled Laws, by adding section 24d

THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- Section 1 Act No 278 of the Public Acts of 1909, as
- 2 amended, being sections 78 1 to 78 28 of the Michigan Compiled
- 3 Laws, is amended by adding section 24d to read as follows
- 4 SEC 24D IF THE VILLAGE CHARTER PROVIDES FOR THE APPOINT-
- 5 MENT OF A CHIEF ADMINISTRATIVE OFFICER BY THE LEGISLATIVE BODY,
- 6 THE LEGISLATIVE BODY MAY ENTER INTO AN EMPLOYMENT CONTRACT WITH
- 7 THE CHIEF ADMINISTRATIVE OFFICER EXTENDING BEYOND THE TERMS OF

- 1 THE MEMBERS OF THE LEGISLATIVE BODY UNLESS SUCH AN EMPLOYMENT
- 2 CONTRACT IS PROHIBITED BY THE CHARTER AN EMPLOYMENT CONTRACT
- 3 WITH A CHIEF ADMINISTRATIVE OFFICER SHALL BE IN WRITING AND SHALL
- 4 SPECIFY THE COMPENSATION TO BE PAID TO THE CHIEF ADMINISTRATIVE
- 5 OFFICER, ANY PROCEDURE FOR CHANGING THE COMPENSATION, ANY FRINGE
- 6 BENEFITS, AND ANY OTHER CONDITIONS OF EMPLOYMENT IF THE CHIEF
- 7 ADMINISTRATIVE OFFICER SERVES AT THE PLEASURE OF THE LEGISLATIVE
- 8 BODY, THE CONTRACT SHALL SO STATE AND MAY PROVIDE FOR SEVERANCE
- 9 PAY OR OTHER BENEFITS IN THE EVENT THE EMPLOYMENT OF THE CHIEF
- 10 ADMINISTRATIVE OFFICER IS TERMINATED AT THE PLEASURE OF THE LEG-
- 11 ISLATIVE BODY
