

## **SENATE BILL No. 1241**

September 14, 1994, Introduced by Senators HART, CHERRY, MILLER, O'BRIEN, DINGELL, BERRYMAN, KELLY, KOIVISTO, SMITH and WELBORN and referred to the Committee on Judiciary

A bill to amend section 7a of chapter VIII of Act No 175 of the Public Acts of 1927, entitled as amended
"The code of criminal procedure,"
as amended by Act No 48 of the Public Acts of 1988, being section 768 7a of the Michigan Compiled Laws

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- 1 Section 1 Section 7a of chapter VIII of Act No 175 of the
- 2 Public Acts of 1927, as amended by Act No 48 of the Public Acts
- 3 of 1988, being section 768 7a of the Michigan Compiled Laws, is
- 4 amended to read as follows
- 5 CHAPTER VIII
- 6 Sec 7a (1) A person who is incarcerated in a penal or
- 7 reformatory institution in this state CORRECTIONAL FACILITY, or
- 8 who escapes from -such an institution A STATE CORRECTIONAL
- 9 FACILITY, and who commits a crime during that incarceration or

- 1 escape -which THAT is punishable by imprisonment in a -penal or
- 2 reformatory institution in this state CORRECTIONAL FACILITY
- 3 shall, upon conviction of that crime, be sentenced as provided by
- 4 law The term of imprisonment imposed for the crime shall begin
- 5 to run at the expiration of the term or terms of imprisonment
- 6 -which the person is serving or has become liable to serve in a
- 7 -penal or reformatory institution in this state CORRECTIONAL
- 8 FACILITY
- 9 (2) If a person is convicted and sentenced to a term of
- 10 imprisonment for a felony committed while the person was on
- 11 parole from a sentence for a previous offense, the term of
- 12 imprisonment imposed for the later offense shall begin to run at
- 13 the expiration of the remaining portion of the MAXIMUM term of
- 14 imprisonment imposed for the previous offense
- 15 (3) The powers conferred upon the court by this section are
- 16 supplementary to any other power conferred by law
- 17 (4) AS USED IN THIS SECTION, "STATE CORRECTIONAL FACILITY"
- 18 MEANS A FACILITY OR INSTITUTION THAT HOUSES A PRISONER POPULATION
- 19 AND IS UNDER THE JURISDICTION OF THE STATE DEPARTMENT OF
- 20 CORRECTIONS
- 21 Section 2 This amendatory act applies to prisoners sen-
- 22 tenced after January 6, 1993 for felonies committed while on
- 23 parole
- 24 Section 3 This amendatory act shall not take effect unless
- 25 Senate Bill No 1242
- 26 of the 87th Legislature is enacted into law
