September 21, 1994, Introduced by Senators BERRYMAN, HART, KOIVISTO, FAUST and MILLER and referred to the Committee on Finance

A bill to amend Act No 281 of the Public Acts of 1967, entitled

"Income tax act of 1967,"

as amended, being sections 206 1 to 206 532 of the Michigan Compiled Laws by adding section 438

THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- 1 Section 1 Act No 281 of the Public Acts of 1967, as
- 2 amended, being sections 206 1 to 206 532 of the Michigan Compiled
- 3 Laws, is amended by adding section 438 to read as follows
- 4 SEC 438 (1) FOR THE 1995 TAX YEAR AND EACH TAX YEAR AFTER
- 5 1995, A TAXPAYER THAT IS ENTITLED TO A TAX REFUND UNDER THIS ACT
- 6 SUFFICIENT TO MAKE A DESIGNATION UNDER THIS SECTION MAY DESIGNATE
- 7 THAT \$2 00 OR MORE OF HIS OR HER REFUND BE CREDITED TO THE
- 8 CITIZENS' POLICE PROTECTION ENHANCEMENT FUND

- 1 (2) THE TAX DESIGNATION AUTHORIZED IN THIS SECTION SHALL BE
- 2 CLEARLY AND UNAMBIGUOUSLY PRINTED ON THE FIRST PAGE OF THE STATE
- 3 INDIVIDUAL INCOME TAX RETURN FORMS
- 4 (3) THE DEPARTMENT SHALL ASSIGN AN IDENTIFICATION NUMBER TO
- 5 EACH POLICE DEPARTMENT AND COUNTY SHERIFF'S DEPARTMENT IN THIS
- 6 STATE THOSE NUMBERS SHALL BE PRINTED NEXT TO THE TAX DESIGNA-
- 7 TION PRINTED PURSUANT TO SUBSECTION (2)
- 8 (4) NOTWITHSTANDING ANY OTHER ALLOCATIONS OR DISBURSEMENTS
- 9 REQUIRED BY THIS ACT, THE DEPARTMENT SHALL TRANSMIT TO EACH
- 10 POLICE DEPARTMENT AND COUNTY SHERIFF'S DEPARTMENT AN AMOUNT EQUAL
- 11 TO THE CUMULATIVE AMOUNT DESIGNATED TO THAT POLICE DEPARTMENT OR
- 12 COUNTY SHERIFF'S DEPARTMENT FOR A CITIZENS' POLICE ENHANCEMENT
- 13 PROGRAM, LESS THE AMOUNT APPROPRIATED TO THE DEPARTMENT TO IMPLE-
- 14 MENT THIS SECTION, NO LATER THAN JULY 15 OF THE YEAR IMMEDIATELY
- 15 FOLLOWING THE TAX YEAR IN WHICH THE DESIGNATION WAS MADE
- 16 (5) AS USED IN THIS SECTION, "CITIZENS' POLICE PROTECTION
- 17 ENHANCEMENT FUND" MEANS THE FUND ESTABLISHED IN SECTION 3 OF THE
- 18 CITIZENS' POLICE PROTECTION ENHANCEMENT FUND ACT
- 19 Section 2 This amendatory act shall not take effect unless
- 20 Senate Bill No 1285
- 21 of the 87th Legislature is enacted into law
