

## **SENATE BILL No. 1296**

November 10, 1994, Introduced by Senator KELLY and referred to the Committee on Education

A bill to amend Act No 331 of the Public Acts of 1966, entitled

"Community college act of 1966,"

as amended, being sections 389 1 to 389 195 of the Michigan Compiled Laws, by adding sections 83a, 83b, 83c, 83d, and 83e

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- 1 Section 1 Act No 331 of the Public Acts of 1966, as
- 2 amended, being sections 389 1 to 389 195 of the Michigan Compiled
- 3 Laws, is amended by adding sections 83a, 83b, 83c, 83d, and 83e
- 4 to read as follows
- 5 SEC 83A (1) THE BOARD OF TRUSTEES SHALL MEET AT LEAST
- 6 ONCE EVERY SEMESTER FOR 2 CONSECUTIVE DAYS
- 7 (2) AT EACH BOARD OF TRUSTEES MEETING, EACH TRUSTEE SHALL
- 8 SUBMIT A WRITTEN ACKNOWLEDGMENT OF ACTUAL OR POTENTIAL CONFLICTS
- 9 OF INTEREST A TRUSTEE SHALL ABSTAIN FROM VOTING ON OR

- 1 DISCUSSING AN ISSUE THAT INVOLVES AN ACTUAL OR POTENTIAL CONFLICT
- 2 OF INTEREST FOR THAT TRUSTEE THE FAILURE TO ABSTAIN FROM THESE
- 3 VOTES OR DISCUSSIONS IS A FELONY
- 4 SEC 83B (1) THE BOARD OF TRUSTEES MAY ACT ONLY UPON A
- 5 RECOMMENDATION, RESOLUTION, OR ACTION PROPOSAL SUBMITTED TO IT BY
- 6 THE COLLEGE PRESIDENT
- 7 (2) THE BOARD OF TRUSTEES SHALL COMMUNICATE WITH COLLEGE
- 8 PERSONNEL, STUDENTS, AND OTHER MEMBERS OF THE COLLEGE COMMUNITY
- 9 ONLY THROUGH THE COLLEGE PRESIDENT
- 10 SEC 83C (1) THE BOARD OF TRUSTEES SHALL ESTABLISH IN EACH
- 11 ANNUAL BUDGET THE STAFF POSITIONS NEEDED TO OPERATE THE COLLEGE
- 12 AND THE QUALIFICATIONS NEEDED TO FILL EACH POSITION
- 13 (2) THE COLLEGE PRESIDENT SHALL MAKE, WITH THE CONCURRENCE
- 14 OF THE BOARD OF TRUSTEES, ALL DECISIONS TO HIRE, EVALUATE, AND
- 15 TERMINATE PERSONNEL THE COLLEGE PRESIDENT SHALL REPORT TO AND
- 16 BE EVALUATED BY THE BOARD OF TRUSTEES
- 17 (3) EACH TRUSTEE IS PERSONALLY LIABLE FOR PERSONNEL ACTIONS
- 18 TAKEN BY THE BOARD OF TRUSTEES WITHOUT THE RECOMMENDATION OF THE
- 19 COLLEGE PRESIDENT, EXCEPT FOR PERSONNEL ACTIONS REGARDING THE
- 20 COLLEGE PRESIDENT'S EMPLOYMENT
- 21 (4) EACH TRUSTEE IS PERSONALLY LIABLE FOR A JUDGMENT FOR
- 22 DAMAGES RESULTING FROM WRONGFUL DISCHARGE OF AN EMPLOYEE IN VIO-
- 23 LATION OF THE LAW OR OF COLLEGE OR BOARD POLICIES
- 24 SEC 83D ALL BOARD OF TRUSTEES' POLICY MANUALS AND BYLAWS
- 25 SHALL BE SUBMITTED TO THE SUPERINTENDENT OF PUBLIC INSTRUCTION
- 26 FOR HIS OR HER APPROVAL BEFORE BEING IMPLEMENTED AND, IF

- 1 APPROPRIATE, MAY BE AMENDED BY THE SUPERINTENDENT OF PUBLIC
- 2 INSTRUCTION
- 3 SEC 83E THE COMMUNITY COLLEGE SHALL EMPLOY A GENERAL
- 4 COUNSEL AS AN EMPLOYEE OF THE COMMUNITY COLLEGE DISTRICT THE
- 5 GENERAL COUNSEL MAY OFFER LEGAL ADVICE TO THE COLLEGE PRESIDENT,
- 6 THE BOARD OF TRUSTEES, AND THE COLLEGE COMMUNITY AT LARGE THE
- 7 GENERAL COUNSEL SHALL REPORT TO THE COLLEGE PRESIDENT
