



SENATE BILL No. 1307

November 10, 1994, Introduced by Senator EMMONS and referred to the Committee on Finance.

A bill to amend section 1211c of Act No. 451 of the Public Acts of 1976, entitled as amended

"The school code of 1976,"

as amended by Act No. 258 of the Public Acts of 1994, being section 380.1211c of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 1211c of Act No. 451 of the Public Acts
2 of 1976, as amended by Act No. 258 of the Public Acts of 1994,
3 being section 380.1211c of the Michigan Compiled Laws, is amended
4 to read as follows:

5 Sec. 1211c. (1) For 1994 through 1996, ~~—a~~ IF A SCHOOL DIS-
6 TRICT HAS LEVIED THE MAXIMUM NUMBER OF MILLS ON BOTH HOMESTEADS
7 AND NONHOMESTEADS THAT THE SCHOOL DISTRICT IS ALLOWED TO LEVY
8 UNDER SECTION 1211, AS CERTIFIED BY THE DEPARTMENT OF TREASURY,
9 THE school district may levy, in addition to the MAXIMUM millage

1 authorized under section 1211, not ~~to exceed~~ MORE THAN 3
2 ADDITIONAL mills for ~~operating~~ ENHANCEMENT purposes if approved
3 by the school electors at an election held after 1993. REVENUE
4 FROM ENHANCEMENT MILLAGE LEVIED UNDER THIS SECTION SHALL NOT BE
5 USED TO FUND A DEFICIT IN A SCHOOL DISTRICT'S OPERATING FUNDS FOR
6 THE CURRENT SCHOOL FISCAL YEAR OR A PRECEDING SCHOOL FISCAL YEAR.
7 The question of levying mills authorized under this section shall
8 be presented to school electors as a separate question, WHICH
9 SHALL BE CLEARLY CAPTIONED ON THE BALLOT AS AN ENHANCEMENT
10 MILLAGE. IF A SCHOOL DISTRICT LEVIES ANY MILLAGE UNDER THIS SEC-
11 TION, THAT SCHOOL DISTRICT SHALL NOT REDUCE THE MILLAGE LEVIED OR
12 INCREASE THE NUMBER OF MILLS EXEMPTED UNDER SECTION 1211 AS LONG
13 AS THE MILLAGE LEVIED UNDER THIS SECTION IS IN EFFECT. MILLAGE
14 APPROVED UNDER THIS SECTION SHALL NOT BE LEVIED UNTIL AT LEAST 90
15 DAYS AFTER THE DATE OF THE ELECTION AT WHICH THE MILLAGE IS
16 APPROVED.

17 (2) AS USED IN THIS SECTION, "HOMESTEAD" MEANS THAT TERM AS
18 DEFINED IN SECTION 1211.

19 Section 2. This amendatory act shall not take effect unless
20 House Bill No. 5067 of the 87th Legislature is enacted into law.
