A bill to amend Act No. 280 of the Public Acts of 1939, entitled as amended

"The social welfare act,"

as amended, being sections 400.1 to 400.119b of the Michigan Compiled Laws, by adding section 106a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 280 of the Public Acts of 1939, as
- 2 amended, being sections 400.1 to 400.119b of the Michigan
- 3 Compiled Laws, is amended by adding section 106a to read as
- 4 follows:
- 5 SEC. 106A. (1) THE DEPARTMENT SHALL PROVIDE MEDICAL ASSIST-
- 6 ANCE TO AN INDIVIDUAL WHO IS ELIGIBLE UNDER SECTION 106(1)(A),
- 7 (B), (D), AND (E) AND WHO MEETS ALL OF THE FOLLOWING
- 8 REQUIREMENTS:

- 1 (A) HAS HOUSEHOLD INCOME THAT IS MORE THAN 100% BUT LESS
- 2 THAN 201% OF THE OFFICIAL POVERTY LINE ESTABLISHED IN THE POVERTY
- 3 GUIDELINES ISSUED BY THE SECRETARY OF HEALTH AND HUMAN SERVICES
- 4 UNDER AUTHORITY OF SECTION 673(2) OF THE COMMUNITY SERVICES BLOCK
- 5 GRANT ACT, SUBTITLE B OF TITLE VI OF THE OMNIBUS BUDGET RECONCIL-
- 6 IATION ACT OF 1981, PUBLIC LAW 97-35, 42 U.S.C. 9902.
- 7 (B) PAYS AN ANNUAL PREMIUM AMOUNT THAT IS THE SAME PERCEN-
- 8 TAGE OF THE ANNUAL COST TO THE DEPARTMENT OF PROVIDING MEDICAL
- 9 ASSISTANCE TO A HOUSEHOLD OF THE SIZE OF THE INDIVIDUAL'S HOUSE-
- 10 HOLD AS THE PERCENTAGE BY WHICH THE INDIVIDUAL'S HOUSEHOLD INCOME
- 11 EXCEEDS THE OFFICIAL POVERTY LINE. BY WAY OF EXAMPLE, AN INDI-
- 12 VIDUAL WHOSE HOUSEHOLD INCOME IS 125% OF THE OFFICIAL POVERTY
- 13 LINE SHALL PAY AN ANNUAL PREMIUM AMOUNT THAT IS 25% OF THE ANNUAL
- 14 COST TO THE DEPARTMENT OF PROVIDING MEDICAL ASSISTANCE TO A
- 15 HOUSEHOLD OF THAT SIZE.
- 16 (2) FOR PURPOSES OF ESTABLISHING FINANCIAL ELIGIBILITY UNDER
- 17 THIS SECTION, THE DEPARTMENT SHALL DISREGARD INCOME AS PROVIDED
- 18 IN SECTION 107.
- 19 Section 2. This amendatory act shall not take effect unless
