

HOUSE BILL No. 4122

January 17, 1995, Introduced by Rep. Varga and referred to the Committee on Human Services.

A bill to amend Act No. 218 of the Public Acts of 1979, entitled as amended

"Adult foster care facility licensing act," as amended, being sections 400.701 to 400.737 of the Michigan Compiled Laws, by adding section 34a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 218 of the Public Acts of 1979, as
- 2 amended, being sections 400.701 to 400.737 of the Michigan
- 3 Compiled Laws, is amended by adding section 34a to read as
- 4 follows:
- 5 ' SEC. 34A. (1) A LICENSEE SHALL NOT EMPLOY AN INDIVIDUAL OR
- 6 UTILIZE AN INDIVIDUAL AS A VOLUNTEER IN AN ADULT FOSTER CARE
- 7 FACILITY UNLESS THE INDIVIDUAL PROVIDES THE LICENSEE WITH A
- 8 DOCUMENT FROM THE SHERIFF OF THE COUNTY IN WHICH THE LICENSED
- 9 FACILITY IS LOCATED OR FROM THE STATE POLICE STATING THAT THE

- I APPLICANT HAS NOT BEEN CONVICTED IN THIS STATE OR IN ANOTHER
- 2 STATE OF A FELONY OR AN ATTEMPT OR CONSPIRACY TO COMMIT A
- 3 FELONY.
- 4 (2) A LICENSEE SHALL ADVISE ANY INDIVIDUAL WHO APPLIES FOR
- 5 EMPLOYMENT OR A VOLUNTEER POSITION WITH THE LICENSEE THAT IN
- 6 ORDER TO OBTAIN EMPLOYMENT OR VOLUNTEER AT THE ADULT FOSTER CARE
- 7 FACILITY, THE INDIVIDUAL MUST DO ALL OF THE FOLLOWING:
- 8 (A) APPEAR BEFORE THE SHERIFF OF THE COUNTY IN WHICH THE
- 9 LICENSED FACILITY IS LOCATED OR THE STATE POLICE AND BE
- 10 FINGERPRINTED.
- (B) REQUEST THE SHERIFF OR THE STATE POLICE TO DETERMINE
- 12 THROUGH THE USE OF THE LAW ENFORCEMENT INFORMATION NETWORK AND
- 13 OTHER RECORDS TO WHICH THE SHERIFF OR STATE POLICE HAS ACCESS
- 14 WHETHER THE INDIVIDUAL HAS BEEN CONVICTED OF A FELONY OR AN
- 15 ATTEMPT OR CONSPIRACY TO COMMIT A FELONY IN THIS STATE OR IN
- 16 ANOTHER STATE.
- (C) IF THE RECORDS OF THE SHERIFF OR STATE POLICE SHOW THAT
- 18 THE INDIVIDUAL HAS NOT BEEN CONVICTED OF A FELONY OR AN ATTEMPT
- 19 OR CONSPIRACY TO COMMIT A FELONY IN THIS STATE OR IN ANOTHER
- 20 STATE, OBTAIN A STATEMENT TO THAT EFFECT FROM THE SHERIFF OR
- 21 STATE POLICE.
- 22 (D) SUBMIT THE STATEMENT DESCRIBED IN SUBDIVISION (C) TO THE
- 23 LICENSEE AS PART OF THE APPLICATION PROCESS.
- 24 (3) THE LICENSEE SHALL PROVIDE THE APPLICANT WITH INFORMA-
- 25 TION ON HOW AND WHERE TO OBTAIN THE INFORMATION REQUIRED BY THIS
