

HOUSE BILL No. 4125

January 17, 1995, Introduced by Rep. Varga and referred to the Committee on Judiciary and Civil Rights.

A bill to amend Act No. 280 of the Public Acts of 1939, entitled as amended

"The social welfare act,"

as amended, being sections 400.1 to 400.119b of the Michigan Compiled Laws, by adding section 14d.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 280 of the Public Acts of 1939, as
- 2 amended, being sections 400.1 to 400.119b of the Michigan
- 3 Compiled Laws, is amended by adding section 14d to read as
- 4 follows:
- 5 SEC. 14D. (1) THE DEPARTMENT SHALL ESTABLISH AND MAINTAIN A
- 6 24-HOUR TOLL-FREE TELEPHONE LINE NAMED THE FAMILY VIOLENCE HOT
- 7 LINE. THE DEPARTMENT SHALL STAFF THE FAMILY VIOLENCE HOT LINE
- 8 WITH INDIVIDUALS WHO ARE TRAINED TO RESPOND TO CALLS RELATED TO

- 1 FAMILY VIOLENCE INCLUDING AT LEAST DOMESTIC VIOLENCE, CHILD
- 2 ABUSE, AND RUNAWAY CHILDREN.
- 3 (2) THE FAMILY VIOLENCE HOT LINE FUND IS CREATED IN THE
- 4 STATE TREASURY. THE STATE TREASURER SHALL DEPOSIT IN THE FUND
- 5 MONEY TRANSMITTED BY THE STATE REGISTRAR UNDER SECTION 4A OF ACT
- 6 NO. 128 OF THE PUBLIC ACTS OF 1887, BEING SECTION 551.104A OF THE
- 7 MICHIGAN COMPILED LAWS, AND SECTION 2832A OF THE PUBLIC HEALTH
- 8 CODE, ACT NO. 368 OF THE PUBLIC ACTS OF 1978, BEING SECTION
- 9 333.2832A OF THE MICHIGAN COMPILED LAWS, AND OTHER MONEY APPRO-
- 10 PRIATED, GRANTED, OR DONATED TO THE FUND. MONEY IN THE FUND
- 11 SHALL BE USED ONLY FOR THE ESTABLISHMENT, MAINTENANCE, AND STAFF-
- 12 ING OF THE FAMILY VIOLENCE HOT LINE.
- 13 Section 2. This amendatory act shall not take effect unless
- 14 all of the following bills of the 88th Legislature are enacted
- 15 into law:
