A bill to amend Act No. 451 of the Public Acts of 1976, entitled as amended
"The school code of 1976,"
as amended, being sections 380.1 to 380.1852 of the Michigan Compiled Laws, by adding section 1230a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 451 of the Public Acts of 1976, as
- 2 amended, being sections 380.1 to 380.1852 of the Michigan
- 3 Compiled Laws, is amended by adding section 1230a to read as
- 4 follows:
- 5 SEC. 1230A. (1) IN ADDITION TO THE CRIMINAL HISTORY CHECK
- 6 REQUIRED UNDER SECTION 1230, THE BOARD OF A SCHOOL DISTRICT,
- 7 LOCAL ACT SCHOOL DISTRICT, PUBLIC SCHOOL ACADEMY, OR INTERMEDIATE
- 8 SCHOOL DISTRICT OR THE GOVERNING BODY OF A NONPUBLIC SCHOOL MAY

- I REQUEST THE DEPARTMENT OF STATE POLICE TO CONDUCT A CRIMINAL
- 2 RECORDS CHECK THROUGH THE FEDERAL BUREAU OF INVESTIGATION ON AN
- 3 APPLICANT FOR, OR AN INDIVIDUAL WHO IS HIRED FOR, A POSITION AS A
- 4 TEACHER OR A SCHOOL ADMINISTRATOR OR A POSITION REQUIRING STATE
- 5 BOARD APPROVAL. A BOARD OR GOVERNING BODY REQUESTING A CRIMINAL
- 6 RECORDS CHECK UNDER THIS SECTION SHALL REQUIRE THE APPLICANT OR
- 7 INDIVIDUAL TO SUBMIT HIS OR HER FINGERPRINTS TO THE DEPARTMENT OF
- 8 STATE POLICE FOR THAT PURPOSE. THE DEPARTMENT OF STATE POLICE
- 9 MAY CHARGE A FEE FOR CONDUCTING THE CRIMINAL RECORDS CHECK.
- 10 (2) AS USED IN THIS SECTION, "STATE BOARD APPROVAL" MEANS
- II THAT TERM AS DEFINED IN SECTION 1539B.
