

HOUSE BILL No. 4686

April 4, 1995, Introduced by Reps. Agee, Yokich, Profit and Pitoniak and referred to the Committee on Appropriations.

A bill to amend Act No. 94 of the Public Acts of 1979, entitled as amended

"The state school aid act of 1979," as amended, being sections 388.1601 to 388.1772 of the Michigan Compiled Laws, by adding section 94.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 94 of the Public Acts of 1979, as
- 2 amended, being sections 388.1601 to 388.1772 of the Michigan
- 3 Compiled Laws, is amended by adding section 94 to read as
- 4 follows:
- 5 SEC. 94. FROM THE APPROPRIATION IN SECTION 11, THERE IS
- 6 ALLOCATED AN AMOUNT NOT TO EXCEED \$10,000,000.00 FOR 1995-96 FOR
- 7 GRANTS TO DISTRICTS, TO BE USED FOR LOCAL PROGRAMS DESIGNED TO
- 8 REDUCE A NEGATIVE IMPACT ON SCHOOL SECURITY AND TO ENCOURAGE
- 9 PREVENTION OF VIOLENCE IN SCHOOLS. THE GRANTS SHALL BE AWARDED

- 1 AND ADMINISTERED BY THE DEPARTMENT. THE GRANTS SHALL BE AWARDED
- 2 ON A COMPETITIVE BASIS, ASSURING A BALANCE BETWEEN URBAN, SUBUR-
- 3 BAN, AND RURAL AREAS, BASED ON THE POTENTIAL IMPACT THE LOCAL
- 4 PROGRAM WOULD HAVE FOR REDUCING FACTORS THAT HAVE A NEGATIVE
- 5 IMPACT ON SCHOOL SECURITY AND REDUCING VIOLENCE IN SCHOOLS, AND
- 6 MAY BE MADE FOR ANY LOCAL PROGRAM DESCRIBED IN THIS SECTION,
- 7 INCLUDING, BUT NOT LIMITED TO, ANY OF THE FOLLOWING TYPES OF
- 8 PROGRAMS:
- 9 (A) ACQUISITION OF SECURITY EQUIPMENT.
- 10 (B) OPERATION OF A LOCAL TELEPHONE LINE OR OTHER METHOD FOR
- 11 RECEIVING INFORMATION, WHICH MAY BE ANONYMOUS, CONCERNING PERSONS
- 12 SUSPECTED OF HAVING WEAPONS IN SCHOOLS OR COMMITTING A CRIME
- 13 INVOLVING WEAPONS IN SCHOOLS.
- 14 (C) DEVELOPMENT OR IMPLEMENTATION OF LOCAL PUBLIC EDUCATION
- 15 PROGRAMS AIMED AT REDUCING ACCESS TO WEAPONS BY MINORS AND REDUC-
- 16 ING OTHER FACTORS THAT HAVE A NEGATIVE IMPACT ON SCHOOL
- 17 SECURITY.
- (D) DEVELOPMENT OF ALTERNATIVE EDUCATION PROGRAMS FOR PUPILS
- 19 WHO HAVE BEEN FOUND WITH A WEAPON IN SCHOOL OR WHO HAVE BEEN
- 20 INVOLVED IN OTHER VIOLENCE IN SCHOOL.
- 21 (E) DEVELOPMENT OR IMPLEMENTATION OF ALTERNATIVE DISPUTE
- 22 RESOLUTION PROGRAMS TO TEACH PUPILS HOW TO RESOLVE CONFLICT IN A
- 23 NONVIOLENT AND NONASSAULTIVE MANNER, SUCH AS COURSES DESCRIBED IN
- 24 SECTION 1167 OF THE SCHOOL CODE OF 1976, BEING SECTION 380.1167
- 25 OF THE MICHIGAN COMPILED LAWS.
