



HOUSE BILL No. 4739

April 25, 1995, Introduced by Reps. Alley, Middaugh, Gagliardi, Owen, Griffin, Baird, Randall, McNutt and DeLange and referred to the Committee on Appropriations.

A bill to amend sections 40 and 40a of Act No. 182 of the Public Acts of 1986, entitled "State police retirement act of 1986," section 40a as added by Act No. 139 of the Public Acts of 1992, being sections 38.1640 and 38.1640a of the Michigan Compiled Laws; and to add section 39a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Sections 40 and 40a of Act No. 182 of the Public
2 Acts of 1986, section 40a as added by Act No. 139 of the Public
3 Acts of 1992, being sections 38.1640 and 38.1640a of the Michigan
4 Compiled Laws, are amended and section 39a is added to read as
5 follows:

6 SEC. 39A. (1) EFFECTIVE OCTOBER 1, 1995, THE RETIREMENT
7 ALLOWANCE PAYABLE TO A RETIRANT OR BENEFICIARY OF A DECEASED

1 RETIRANT WHOSE EFFECTIVE DATE OF RETIREMENT WAS BEFORE OCTOBER 1,
2 1986, IS SUPPLEMENTED AS FOLLOWS:

14 (2) THE RECALCULATED RETIREMENT ALLOWANCE UNDER THIS SECTION
15 SHALL BE THE BASIS UPON WHICH FUTURE ADJUSTMENTS TO THE RETIRE-
16 MENT ALLOWANCE, INCLUDING THE INCREASES UNDER SECTION 40, IF
17 APPLICABLE, AND SECTION 40A, ARE CALCULATED.

1 (2) THE INCREASED RETIREMENT ALLOWANCE UNDER THIS SECTION
2 SHALL BE THE BASIS UPON WHICH FUTURE ADJUSTMENTS TO THE
3 RETIREMENT ALLOWANCE, INCLUDING THE INCREASE UNDER SECTION 40A,
4 ARE CALCULATED.

5 Sec. 40a. (1) A member or deferred member who retires after
6 September 30, 1991, or a retirement allowance beneficiary of a
7 member or deferred member who dies or retires after September 30,
8 1991, is entitled to have his or her retirement allowance
9 increased as provided in this section. BEGINNING OCTOBER 1,
10 1995, A RETIRANT OR RETIREMENT ALLOWANCE BENEFICIARY IS ENTITLED
11 TO HAVE HIS OR HER RETIREMENT ALLOWANCE INCREASED AS PROVIDED IN
12 THIS SECTION.

13 (2) ~~The~~ THROUGH OCTOBER 1, 1994, THE retirement allowance
14 of a member, deferred member, or retirement allowance beneficiary
15 described in subsection (1) shall be increased each October 1,
16 beginning with the later of October 1, 1992 or the first October
17 1 that is at least 12 months after the retirement allowance
18 effective date. BEGINNING OCTOBER 1, 1995, THE RETIREMENT ALLOW-
19 ANCE OF A RETIRANT OR A RETIREMENT ALLOWANCE BENEFICIARY SHALL BE
20 INCREASED EACH OCTOBER 1 BEGINNING WITH THE LATER OF OCTOBER 1,
21 1995 OR THE FIRST OCTOBER 1 THAT IS AT LEAST 12 MONTHS AFTER THE
22 RETIREMENT ALLOWANCE EFFECTIVE DATE. The amount of the annual
23 increase shall be 2% of the retirement allowance that would be
24 payable without application of this section. The annual increase
25 shall not exceed \$500.00.
