

## HOUSE BILL No. 4813

May 10, 1995, Introduced by Reps. Gubow, Leland and Gire and referred to the Committee on Health Policy.

A bill to amend sections 16131, 16146, and 16263 of Act No. 368 of the Public Acts of 1978, entitled as amended "Public health code,"

section 16131 as amended by Act No. 80 of the Public Acts of 1993, section 16146 as amended by Act No. 462 of the Public Acts of 1988, and section 16263 as amended by Act No. 216 of the Public Acts of 1990, being sections 333.16131, 333.16146, and 333.16263 of the Michigan Compiled Laws; to add section 16348 and part 185; and to repeal acts and parts of acts.
