



# HOUSE BILL No. 4878

May 18, 1995, Introduced by Reps. Johnson, Hill, Ryan, Kukuk, Gire, Schroer, Goschka, Gilmer, Emerson, Dobb, Horton, Hanley, Green, McManus, Crissman, Bodem and Price and referred to the Committee on Human Services.

A bill to amend section 8 of Act No. 250 of the Public Acts of 1982, entitled "Child abuse and neglect prevention act," being section 722.608 of the Michigan Compiled Laws.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1 Section 1. Section 8 of Act No. 250 of the Public Acts of  
2 1982, being section 722.608 of the Michigan Compiled Laws, is  
3 amended to read as follows:

4 Sec. 8. (1) The state board may ~~accept~~ DO ANY OF THE  
5 FOLLOWING:

6 (A) ACCEPT federal ~~funds~~ MONEY granted by congress or  
7 executive order for the purposes of this act as well as gifts,  
8 GRANTS, BEQUESTS, and donations from individuals, private  
9 organizations, or foundations. The acceptance and use of federal  
10 ~~funds~~ MONEY does not commit state ~~funds~~ MONEY and does not

1 place an obligation upon the legislature to continue the purposes  
2 for which the federal ~~funds are~~ MONEY IS made available. ~~All~~  
3 ~~funds~~

4 (B) ENTER INTO A CONTRACT WITH A CHARITABLE ORGANIZATION  
5 LICENSED UNDER THE CHARITABLE ORGANIZATIONS AND SOLICITATIONS  
6 ACT, ACT NO. 169 OF THE PUBLIC ACTS OF 1975, BEING SECTIONS  
7 400.271 TO 400.294 OF THE MICHIGAN COMPILED LAWS, FOR THE SOLICI-  
8 TATION OF CONTRIBUTIONS TO BE USED EXCLUSIVELY FOR THE PURPOSES  
9 PRESCRIBED BY SECTION 9. A CONTRACT UNDER THIS SUBDIVISION SHALL  
10 INCLUDE PROVISIONS FOR AT LEAST ALL OF THE FOLLOWING:

11 (i) A REASONABLE ADMINISTRATIVE FEE FOR CONTRIBUTIONS  
12 OBTAINED BY THE CHARITABLE ORGANIZATION.

13 (ii) AN INDEPENDENT AUDIT OF THE CHARITABLE ORGANIZATION IN  
14 REGARD TO THE SOLICITATION.

15 (iii) APPROPRIATE BONDING BY THE CHARITABLE ORGANIZATION.

16 (C) PLAN, MANAGE, OR CONDUCT A CAMPAIGN TO SOLICIT GIFTS,  
17 BEQUESTS, GRANTS, OR DONATIONS OF MONEY OR PROPERTY, OR PLEDGES  
18 OF GIFTS, BEQUESTS, GRANTS, OR DONATIONS.

19 (2) MONEY received in the manner described in this section  
20 shall be transmitted to the state treasurer for deposit in the  
21 trust fund ~~—~~ and shall be made available for expenditure as  
22 appropriated by the legislature.
