## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Sections 16131, 16145, 16601, 16611, 16621, and
- 2 16625 of Act No. 368 of the Public Acts of 1978, sections 16131
- 3 and 16145 as amended by Act No. 80 of the Public Acts of 1993 and
- 4 section 16625 as amended by Act No. 58 of the Public Acts of
- 5 1991, being sections 333.16131, 333.16145, 333.16601, 333.16611,

- (2) A board or task force may promulgate rules necessary or
- 25 appropriate to fulfill its functions as prescribed in this
- 26 article. A BOARD OR TASK FORCE SHALL NOT PROMULGATE RULES THAT

- 1 EXPAND, CONSTRICT, OR OTHERWISE MODIFY THE SCOPE OF PRACTICE
- 2 DEFINITION FOR THE HEALTH PROFESSION GOVERNED BY THAT BOARD OR
- 3 TASK FORCE.
- 4 (3) Only a board or task force shall promulgate rules to
- 5 specify requirements for licenses, registrations, renewals, exam-
- 6 inations, and required passing scores.
- 7 PART 165. DENTAL HYGIENE
- 8 SEC. 16501. (1) AS USED IN THIS PART:
- 9 (A) "ALTERNATIVE PRACTICE OF DENTAL HYGIENE" MEANS THE PRAC-
- 10 TICE OF DENTAL HYGIENE BY A DENTAL HYGIENIST PURSUANT TO SECTION
- 11 16625(2).
- 12 (B) "ASSIGNMENT" MEANS THAT A DENTIST HAS DESIGNATED A
- 13 PATIENT OF RECORD UPON WHOM SERVICES ARE TO BE PERFORMED BY A
- 14 DENTAL HYGIENIST AND HAS DESCRIBED THE PROCEDURES TO BE
- 15 PERFORMED. THE DENTIST NEED NOT BE PHYSICALLY PRESENT IN THE
- 16 OFFICE OR IN THE TREATMENT ROOM AT THE TIME THE PROCEDURES ARE
- 17 BEING PERFORMED.
- 18 (C) "DENTAL HYGIENIST" MEANS AN INDIVIDUAL LICENSED UNDER
- 19 THIS PART TO ENGAGE IN THE PRACTICE OF DENTAL HYGIENE.
- 20 (D) "PRACTICE OF DENTAL HYGIENE" MEANS PRACTICE AT THE
- 21 ASSIGNMENT OF A DENTIST IN THAT SPECIFIC AREA OF DENTISTRY BASED
- 22 ON SPECIALIZED KNOWLEDGE, FORMAL EDUCATION, AND SKILL WITH PAR-
- 23 TICULAR EMPHASIS ON PREVENTIVE SERVICES AND ORAL HEALTH
- 24 EDUCATION.
- (E) "SUPERVISION" MEANS THAT TERM AS DEFINED IN
- 26 SECTION 16625(4).

- 1 (2) IN ADDITION, ARTICLE | CONTAINS GENERAL DEFINITIONS AND
- 2 PRINCIPLES OF CONSTRUCTION APPLICABLE TO ALL ARTICLES IN THIS
- 3 CODE AND PART 161 CONTAINS DEFINITIONS APPLICABLE TO THIS PART.
- 4 SEC. 16503. THE MICHIGAN BOARD OF DENTAL HYGIENE IS CREATED
- 5 IN THE DEPARTMENT. THE BOARD CONSISTS OF THE FOLLOWING 9 VOTING
- 6 MEMBERS WHO SHALL MEET THE REOUIREMENTS OF PART 161: 5 DENTAL
- 7 HYGIENISTS AND 4 PUBLIC MEMBERS. THE BOARD MEETING DATES AND
- 8 TIMES SHALL BE CONCURRED IN BY A VOTE OF NOT LESS THAN 5 BOARD
- 9 MEMBERS.
- 10 SEC. 16505. UNLESS AMENDED OR RESCINDED BY THE BOARD, RULES
- 11 PROMULGATED ON OR BEFORE THE EFFECTIVE DATE OF THIS PART BY THE
- 12 MICHIGAN BOARD OF DENTISTRY UNDER SECTION 16625 AND PERTAINING TO
- 13 THE PRACTICE OF DENTAL HYGIENE REMAIN IN FULL FORCE AND EFFECT.
- 14 AFTER THE EFFECTIVE DATE OF THIS PART, THE MICHIGAN BOARD OF
- 15 DENTAL HYGIENE SHALL ENFORCE THE RULES DESCRIBED IN THIS SECTION.
- 16 SEC. 16507. (1) AN INDIVIDUAL SHALL NOT ENGAGE IN THE PRAC-
- 17 TICE OF DENTAL HYGIENE OR IN THE ALTERNATIVE PRACTICE OF DENTAL
- 18 HYGIENE UNLESS LICENSED OR OTHERWISE AUTHORIZED BY THIS ARTICLE.
- 19 (2) DEEP SCALING, ROOT PLANING, AND THE REMOVAL OF CALCAR-
- 20 EOUS DEPOSITS SHALL BE PERFORMED ONLY BY AN INDIVIDUAL LICENSED
- 21 UNDER THIS ARTICLE AS A DENTAL HYGIENIST OR A DENTIST.
- 22 (3) THE BOARD SHALL NOT ISSUE A LICENSE UNDER THIS PART TO
- 23 AN INDIVIDUAL UNLESS THAT INDIVIDUAL IS A GRADUATE OF A DENTAL
- 24 HYGIENE PROGRAM WITH A MINIMUM OF 2 ACADEMIC YEARS OF CURRICULUM
- 25 PROVIDED IN A COLLEGE OR INSTITUTION OF HIGHER EDUCATION, WHICH
- 26 PROGRAM IS ACCREDITED BY A NATIONAL AGENCY RECOGNIZED BY THE

- 1 COUNCIL ON POSTSECONDARY ACCREDITATION OR THE UNITED STATES
- 2 DEPARTMENT OF EDUCATION AND IS APPROVED BY THE BOARD.
- 3 (4) A DENTAL HYGIENIST'S LICENSE ISSUED BY THE MICHIGAN
- 4 BOARD OF DENTISTRY IS VALID UNTIL ITS EXPIRATION DATE. THE
- 5 HOLDER OF A LICENSE DESCRIBED IN THIS SUBSECTION SHALL APPLY FOR
- 6 RENEWAL OF THE LICENSE WITH THE MICHIGAN BOARD OF DENTAL
- 7 HYGIENE. THE MICHIGAN BOARD OF DENTAL HYGIENE SHALL RENEW THE
- 8 LICENSE IF THE APPLICANT MEETS ALL OF THE CONDITIONS FOR RENEWAL.
- 9 SEC. 16509. (!) A DENTAL HYGIENIST SHALL NOT KNOWINGLY FAIL
- 10 TO COMPLY WITH THE INFECTION CONTROL STANDARDS ESTABLISHED BY THE
- 11 OCCUPATIONAL SAFETY AND HEALTH ADMINISTRATION OR THE MICHIGAN
- 12 OCCUPATIONAL SAFETY AND HEALTH ADMINISTRATION AND APPROVED BY THE
- 13 BOARD.
- 14 (2) A DENTAL HYGIENIST SHALL NOT REFUSE, WITHHOLD FROM,
- 15 DENY, OR DISCRIMINATE AGAINST AN INDIVIDUAL WITH REGARD TO PRO-
- 16 VIDING PROFESSIONAL SERVICES THE LICENSEE IS LICENSED AND QUALI-
- 17 FIED TO RENDER BECAUSE THE INDIVIDUAL IS HIV INFECTED OR HBV
- 18 INFECTED.
- 19 (3) AS USED IN THIS SECTION:
- 20 (A) "HBV" MEANS HEPATITIS B VIRUS.
- 21 (B) "HBV INFECTED" MEANS EITHER OF THE FOLLOWING:
- 22 (i) THE STATUS OF AN INDIVIDUAL WHO IS TESTED AS
- 23 HBeAq-POSITIVE.
- 24 (ii) THE STATUS OF AN INDIVIDUAL WHO HAS TESTED
- 25 HBsAg-POSITIVE ON NOT LESS THAN 2 OCCASIONS THAT WERE NOT LESS
- 26 THAN 6 MONTHS APART OR WHO HAS TESTED HBSAg-POSITIVE AND
- 27 IGM-NEGATIVE ON A SINGLE SERUM SPECIMEN.

- (C) "HIV INFECTED" MEANS THAT TERM AS DEFINED IN
- 2 SECTION 5101.
- 3 Sec. 16601. (1) As used in this part:
- 4 (a) "Assignment" means that a dentist has designated a
- 5 patient of record upon whom services are to be performed and has
- 6 described the procedures to be performed. The dentist need not
- 7 be physically present in the office or in the treatment room at
- 8 the time the procedures are being performed.
- 9 (b) "Dental laboratory" means a dental workroom operated as
- 10 a part of a dental office or otherwise, by a person, other than a
- 11 dentist, who is engaged in, or holds himself, herself, or itself
- 12 out as being directly or indirectly engaged in, constructing,
- 13 repairing, or altering prosthetic dentures, bridges, orthodontic
- 14 or other appliances, or structures to be used as substitutes for
- 15 or as a part of human teeth or jaws or associated structures, or
- 16 for the correction of malocclusions or deformities.
- 17 (c) "Dentist" means an individual licensed under this arti-
- 18 cle to engage in the practice of dentistry.
- (d) "Practice of dentistry" means the diagnosis, treatment,
- 20 prescription, or operation for a disease, pain, deformity, defi-
- 21 ciency, injury, or physical condition of the human tooth, teeth,
- 22 alveolar process, gums or jaws, or their dependent tissues, or an
- 23 offer, undertaking, attempt to do, or holding oneself out as able
- 24 to do any of these acts.
- 25 (e) "Practice as a dental assistant" means assistance in the
- 26 clinical practice of dentistry based on formal education,

- 1 specialized knowledge, and skill at the assignment and under the
  2 supervision of a dentist.
- 3 (f) "Practice as a dental hygienist" means practice at the
- 4 assignment of a dentist in that specific area of dentistry based
- 5 on specialized knowledge, formal education, and skill with par
- 6 ticular emphasis on preventive services and oral health
- 7 education.
- 8 (2) In addition, article 1 contains general definitions and
- 9 principles of construction applicable to all articles in this
- 10 code and part 161 contains definitions applicable to this part.
- Sec. 16611. (1) A person shall not engage in the practice
- 12 of dentistry , the practice as a dental hygienist, or the
- 13 ENGAGE IN practice as a dental assistant unless licensed or oth-
- 14 erwise authorized by this article.
- (2) Deep scaling, root planing, and the removal of calcar-
- 16 eous deposits -may only SHALL be performed ONLY by -individuals
- 17 AN INDIVIDUAL licensed UNDER THIS ARTICLE as a dental hygienist
- 18 or a dentist.
- 19 Sec. 16621. (1) The Michigan board of dentistry is created
- 20 in the department. The board shall consist of the following 13
- 21 voting members who shall meet the requirements of part 161: 7
- 22 dentists, -2 dental hygienists, 2 dental assistants, and -2 4
- 23 public members. The board meeting dates and times shall be con-
- 24 curred in by a vote of not less than 10 board members. Not more
- 25 than I member of the board may be a dental school faculty
- 26 member.

- 1 (2) The dental assistants first appointed to the board
- 2 shall be graduates of a dental assisting program accredited by
- 3 the commission on accreditation of the American dental
- 4 association. This subsection shall expire 3 years after the
- 5 effective date of this article.
- 6 (3) The requirement of section 16135(d) that a board member
- 7 shall have practiced that profession for 2 years immediately
- 8 before appointment is waived for 2 years after the effective date
- 9 of this part for members of the board licensed as dental assist
- 10 ants by this part.
- (2) -(4) A board member licensed to practice as a dental
- 12 hygienist or a dental assistant shall vote as an equal member in
- 13 all matters except those designated in section 16148(1) or (2)
- 14 -which THAT apply to dentists and not to -dental hygienists or
- 15 dental assistants.
- 16 (3) THE TERMS OF THE MEMBERS OF THE MICHIGAN BOARD OF DEN-
- 17 TISTRY WHO ARE DENTAL HYGIENISTS EXPIRE ON THE EFFECTIVE DATE OF
- 18 THE AMENDATORY ACT THAT ADDED THIS SUBSECTION.
- 19 Sec. 16625. (1) The board may promulgate rules to prohibit
- 20 or otherwise restrict the assignment of procedures to a dental
- 21 hygienist or a dental assistant if the board determines that the
- 22 assignment constitutes or may constitute a danger to the health,
- 23 safety, or welfare of the patient or the public.
- 24 (2) Notwithstanding section  $\frac{16601(1)(f)}{16501(1)(D)}$  or the
- 25 rules promulgated under subsection (1), a dental hygienist may
- 26 perform dental hygiene services under the supervision of a
- 27 dentist as part of a program for dentally underserved populations

- 1 in this state conducted by a local, state, or federal grantee
- 2 health agency for patients who are not assigned by a dentist.
- 3 The director of public health shall designate a person as a
- 4 grantee health agency for a 2-year period if the person applies
- 5 to the department of public health on a form provided by the
- 6 department of public health and meets all of the following
- 7 requirements:
- 8 (a) Is a public or nonprofit agency administering a program
- 9 of dental care to a dentally underserved population.
- 10 (b) Obtains more than 50% of its total revenue from public
- 11 or nonprofit organization sources.
- (c) Employs or contracts with at least 1 dentist and 1
- 13 dental hygienist.
- (d) Is not associated with a private dental practice or an
- 15 incorporated dental service provider whose only source of state
- 16 or federal funding is reimbursement under the program for medical
- 17 assistance administered by the department of social services
- 18 under the social welfare act, Act No. 280 of the Public Acts of
- 19 1939, being sections 400.1 to -400.121 400.119B of the Michigan
- 20 Compiled Laws.
- (e) Submits a program overview indicating the approximate
- 22 population to be served, the method by which the service is to be
- 23 provided, and the procedures for program oversight and
- 24 direction.
- 25 (3) The director of public health may appoint an advisory
- 26 committee to assist the director of public health in designating
- 27 grantee health agencies under subsection (2). If the director of

- 1 public health does appoint an advisory committee under this
- 2 subsection, the director of public health shall include on the
- 3 advisory committee, at a minimum, a representative from the
- 4 Michigan dental hygienist association or its successor organiza-
- 5 tion and a representative from the Michigan dental association or
- 6 its successor organization.
- 7 (4) As used in this section, "supervision" means the over-
- 8 seeing of or participation in the work of any other individual by
- 9 a health professional licensed under this article in circum-
- 10 stances in which 1 or more of the following exist:
- 11 (a) The continuous availability of direct communication in
- 12 person or by radio, telephone, or telecommunication between the
- 13 supervised individual and a licensed health professional.
- (b) The availability of a licensed health professional on a
- 15 regularly scheduled basis to review the practice of the super-
- 16 vised individual, to provide consultation to the supervised indi-
- 17 vidual, to review records, and to further educate the supervised
- 18 individual in the performance of the individual's functions.
- (c) The provision by the licensed supervising health profes-
- 20 sional of predetermined procedures and drug protocol.
