

HOUSE BILL No. 4900

May 25, 1995, Introduced by Reps. DeMars, Bush and Jersevic and referred to the Committee on Judiciary and Civil Rights.

A bill to amend chapter IV of Act No. 175 of the Public Acts of 1927, entitled as amended
"The code of criminal procedure,"
as amended, being sections 764.1 to 764.29 of the Michigan
Compiled Laws, by adding section 15g.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Chapter IV of Act No. 175 of the Public Acts of
- 2 1927, as amended, being sections 764.1 to 764.29 of the Michigan
- 3 Compiled Laws, is amended by adding section 15g to read as
- 4 follows:
- 5 CHAPTER IV
- 6 SEC. 15G. A CRIMINAL INVESTIGATOR OR POLICE OFFICER OF THE
- 7 FEDERAL DEPARTMENT OF VETERANS AFFAIRS MAY ARREST A PERSON UNDER
- 8 THE SAME CIRCUMSTANCES THAT A PEACE OFFICER MAY ARREST THE PERSON

- 1 AS AUTHORIZED UNDER THIS CHAPTER IF ALL OF THE FOLLOWING ARE
 2 TRUE:
- 3 (A) THE CRIMINAL INVESTIGATOR OR POLICE OFFICER IS ON DUTY.
- 4 (B) THE CRIMINAL INVESTIGATOR OR POLICE OFFICER RECEIVES A
- 5 REQUEST TO ASSIST A PEACE OFFICER IN ARRESTING THE PERSON FROM
- 6 EITHER OF THE FOLLOWING:
- 7 (i) A PEACE OFFICER.
- 8 (ii) A PERSON WHO IS RESPONSIBLE FOR DISPATCHING PEACE OFFI-
- 9 CERS IN RESPONSE TO REQUESTS FOR LAW ENFORCEMENT SERVICES.
- 10 (C) THE CRIMINAL INVESTIGATOR OR POLICE OFFICER HAS RECEIVED
- 11 TRAINING IN THE LAWS OF THIS STATE EQUIVALENT TO THE TRAINING
- 12 PROVIDED FOR AN OFFICER OF A LOCAL POLICE AGENCY UNDER THE
- 13 MICHIGAN LAW ENFORCEMENT OFFICERS TRAINING COUNCIL ACT OF 1965,
- 14 ACT NO. 203 OF THE PUBLIC ACTS OF 1965, BEING SECTIONS 28.601 TO
- 15 28.616 OF THE MICHIGAN COMPILED LAWS.
- 16 Section 2. This amendatory act shall not take effect unless
- 17 Senate Bill No. or House Bill No. 4899 (request
- 18 no. 05056'95 b) of the 88th Legislature is enacted into law.
