A bill to amend section 22205 of Act No. 368 of the Public Acts of 1978, entitled as amended

"Public health code,"

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 22205 of Act No. 368 of the Public Acts
- 2 of 1978, as amended by Act No. 88 of the Public Acts of 1993,
- 3 being section 333.22205 of the Michigan Compiled Laws, is amended
- 4 to read as follows:
- 5 Sec. 22205. (1) "Health facility", except as otherwise pro-
- 6 vided in subsection (2), means:
 - (a) A hospital licensed under part 215.
- 8 (b) A psychiatric hospital, psychiatric unit, or partial
- 9 hospitalization psychiatric program licensed under the mental

- 3 (c) A nursing home licensed under part 217 or a hospital
- 4 long-term care unit as defined in section 20106(6).
- 5 (d) A freestanding surgical outpatient facility licensed 6 under part 208.
- 7 (e) A health maintenance organization licensed under part 8 210.
- 9 (2) "Health facility" does not include the following:
- 10 (a) An institution conducted by and for the adherents of a
- 11 church or religious denomination for the purpose of providing
- 12 facilities for the care and treatment of the sick who depend
- 13 solely upon spiritual means through prayer for healing.
- (b) A health facility or agency located in a correctional
- 15 institution.
- (c) A veterans facility operated by the state or federal

- (d) A facility owned and operated by the department of

- 20 (E) A HOSPITAL LOCATED IN A COUNTY WITH A POPULATION OF
- 21 FEWER THAN 50,000.
- 22 (3) "Initiate" means the initiation of a covered clinical
- 23 service by a person if the covered clinical service has not been
- 24 offered in compliance with this part or former part 221 on a reg-
- 25 ular basis by that person at the location where the covered clin-
- 26 ical service is to be offered within the 12-month period

- i immediately preceding the date the covered clinical service will

- 4 or a related system of components that is used for clinical
