



HOUSE BILL No. 4988

June 16, 1995, Introduced by Reps. Dalman, McBryde, Dobb, Cropsey, Horton, Voorhees, Hammerstrom, DeLange and Goschka and referred to the Committee on Education.

A bill to amend sections 1401, 1411, and 1415 of Act No. 451 of the Public Acts of 1976, entitled as amended "The school code of 1976," being sections 380.1401, 380.1411, and 380.1415 of the Michigan Compiled Laws; and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Sections 1401, 1411, and 1415 of Act No. 451 of
2 the Public Acts of 1976, being sections 380.1401, 380.1411, and
3 380.1415 of the Michigan Compiled Laws, are amended to read as
4 follows:

5 Sec. 1401. ~~-(1)-~~ The board of a school district may admit
6 nonresident pupils to the schools of the district. The board
7 shall determine the rates of tuition of ~~the~~ nonresident pupils
8 WHO DO NOT RESIDE IN THIS STATE and shall collect ~~the~~ tuition
9 FROM THOSE PUPILS ONLY.

1 ~~(2) Tuition for grades K to 6 shall not exceed 25% more~~
 2 ~~than the operation cost per capita for the number of pupils in~~
 3 ~~membership in grades K to 12.~~

4 ~~(3) Tuition for grades 7 to 12 shall not exceed 12 1/2% more~~
 5 ~~than 115% of the operation cost per capita for the number of~~
 6 ~~pupils in membership in grades K to 12.~~

7 ~~(4) In a school district not maintaining grades above the~~
 8 ~~eighth grade, the tuition shall not exceed 25% more than the~~
 9 ~~operation cost per capita for the number of pupils in membership~~
 10 ~~in grades K to 8.~~

11 ~~(5) The operation costs and membership figures of the pre-~~
 12 ~~ceding fiscal year shall be used. The per capita cost used shall~~
 13 ~~not include moneys expended for school sites, school building~~
 14 ~~construction, equipment, payment of bonds, or other purposes not~~
 15 ~~properly included in operation costs as determined by the state~~
 16 ~~board.~~

17 Sec. 1411. (1) ~~In~~ IF A PUPIL WHO HAS COMPLETED EIGHTH
 18 GRADE RESIDES IN A SCHOOL DISTRICT THAT DOES NOT MAINTAIN GRADES
