



# HOUSE BILL No. 5172

September 28, 1995, Introduced by Reps. DeMars, Lowe, Anthony, Hanley, Brewer, DeHart, Yokich, Tesanovich, McBryde, Martinez, Leland, Pitoniak, Willard, Voorhees, Cherry, Whyman, Hammerstrom, Goschka, Freeman, McNutt, Wetters, Dobb, Munsell, Fitzgerald, Horton, Geiger, Stallworth, Perricone, Bullard, Bush, LaForge, Galloway and Ryan and referred to the Committee on Appropriations.

A bill to amend section 411 of Act No. 150 of the Public Acts of 1967, entitled "Michigan military act," as amended by Act No. 280 of the Public Acts of 1980, being section 32.811 of the Michigan Compiled Laws.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1 Section 1. Section 411 of Act No. 150 of the Public Acts of  
2 1967, as amended by Act No. 280 of the Public Acts of 1980, being  
3 section 32.811 of the Michigan Compiled Laws, is amended to read  
4 as follows:

5 Sec. 411. (1) A person who has completed not less than 20  
6 years of active service with the national guard or defense force,  
7 or both, may retire and receive retirement pay under 1 or more of  
8 the following circumstances:

1 (a) Attainment of 62 years of age.

2 (b) Ineligibility, because of federal law or regulation, for  
3 further federal recognition in the person's current grade ~~by~~  
4 ~~reason~~ BECAUSE of age or length of service, and termination of  
5 the person's commission or enlistment in the national guard of  
6 the United States.

7 (c) Withdrawal of the person's federal recognition and ter-  
8 mination of the person's commission or enlistment in the national  
9 guard of the United States because of physical disqualification  
10 from further service.

11 (d) Separation from the national guard or defense force  
12 under an honorable circumstance.

13 (2) A person who retires under subsection (1)(a) shall  
14 receive pay of \$600.00 per year. ~~upon reaching 62 years of age.~~  
15 A person who retires under subsection (1)(b), (c), or (d) shall  
16 receive pay of \$600.00 per year upon reaching 55 years of age.

17 (3) Upon the death of a person ~~eligible to receive retire-~~  
18 ~~ment pay under subsection (1), the~~ WHO HAS COMPLETED NOT LESS  
19 THAN 20 YEARS OF ACTIVE SERVICE WITH THE NATIONAL GUARD OR  
20 DEFENSE FORCE, OR BOTH, A surviving spouse shall receive \$300.00  
21 per year until death.
