



HOUSE BILL No. 5289

October 25, 1995, Introduced by Rep. Sikkema and referred to the Committee on Conservation, Environment and Great Lakes.

A bill to amend section 2 of Act No. 186 of the Public Acts of 1989, entitled
"County department of solid waste management act,"
being section 45.582 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 2 of Act No. 186 of the Public Acts of
2 1989, being section 45.582 of the Michigan Compiled Laws, is
3 amended to read as follows:

4 Sec. 2. As used in this act:

5 (a) "Acquire" means acquisition by any method described in
6 section 12 or by any other method permitted by law.

7 (b) "County" means a county organized under Act No. 139 of
8 the Public Acts of 1973, being sections 45.551 to 45.573 of the
9 Michigan Compiled Laws, except where the context provides
10 otherwise.

1 (c) "Department of solid waste management" means the
2 department of solid waste management provided for in section 3.

3 (d) "Governing body" means, for a county, the county board
4 of commissioners; for a city, the council, commission, or other
5 body having legislative powers; for a village, the council, com-
6 mission board of trustees, or other body having legislative
7 powers; for a general law or charter township, the township
8 board; and for a district or an authority, the body having gen-
9 eral governing powers.

10 (e) "Public corporation" means any county however organized,
11 a city, village, township, charter township, district, or author-
12 ity existing under the laws of this state.

13 (f) "Solid waste system" or "system" means all plants,
14 works, instrumentalities, properties, rights, processes, and con-
15 tracts used or useful in connection with the collection, trans-
16 portation, recycling, processing, storing, or disposing, by
17 treatment, incineration, or otherwise, of solid waste, or as may
18 be provided in a solid waste management plan or update of a solid
19 waste management plan approved FOR A COUNTY pursuant to ~~the~~
20 ~~solid waste management act, Act No. 641 of the Public Acts of~~
21 ~~1978, being sections 299.401 to 299.437 of the Michigan Compiled~~
22 ~~Laws, for a county~~ PART 115 (SOLID WASTE MANAGEMENT) OF THE NAT-
23 URAL RESOURCES AND ENVIRONMENTAL PROTECTION ACT, ACT NO. 451 OF
24 THE PUBLIC ACTS OF 1994, BEING SECTIONS 324.11501 TO 324.11549 OF
25 THE MICHIGAN COMPILED LAWS.

26 (g) "Solid waste" means putrescible and nonputrescible solid
27 wastes, except body wastes, and includes garbage, rubbish, ashes,

1 incinerator ash, incinerator residue, street cleanings, municipal
2 and industrial sludges, commercial and industrial wastes, and any
3 other wastes described in a solid waste management plan or an
4 update of a solid waste management plan approved pursuant to ~~Act~~
5 ~~No. 641 of the Public Acts of 1978~~ PART 115 OF ACT NO. 451 OF
6 THE PUBLIC ACTS OF 1994, for a county.

7 (h) "Solid waste management plan" means the solid waste man-
8 agement plan of a county provided for in ~~the solid waste manage-~~
9 ~~ment act, Act No. 641 of the Public Acts of 1978, being sections~~
10 ~~299.401 to 299.437 of the Michigan Compiled Laws~~ PART 115 OF ACT
11 NO. 451 OF THE PUBLIC ACTS OF 1994.
