



HOUSE BILL No. 5292

October 25, 1995, Introduced by Rep. Hill and referred to the Committee on Conservation, Environment and Great Lakes.

A bill to amend section 25a of Act No. 278 of the Public Acts of 1909, entitled as amended

"The home rule village act,"

as added by Act No. 15 of the Public Acts of 1994, being section 78.25a of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 25a of Act No. 278 of the Public Acts of
2 1909, as added by Act No. 15 of the Public Acts of 1994, being
3 section 78.25a of the Michigan Compiled Laws, is amended to read
4 as follows:

5 Sec. 25a. (1) Consistent with any of the following statutes
6 and whether or not authorized by the village charter, the village
7 council may adopt an ordinance that designates a violation of the
8 ordinance as a civil infraction and provides a civil fine for
9 that violation:

1 (a) The Michigan vehicle code, Act No. 300 of the Public
2 Acts of 1949, being sections 257.1 to 257.923 of the Michigan
3 Compiled Laws.

4 (b) Act No. 235 of the Public Acts of 1969, being
5 sections 257.941 to 257.943 of the Michigan Compiled Laws.

6 (c) Act No. 62 of the Public Acts of 1956, being
7 sections 257.951 to 257.954 of the Michigan Compiled Laws.

8 ~~(2) Consistent with the marine safety act, Act No. 303 of~~
9 ~~the Public Acts of 1967, being sections 281.1001 to 281.1199 of~~
10 ~~the Michigan Compiled Laws, and whether or not authorized by the~~
11 ~~village charter, the village council may adopt an ordinance that~~

16 (2) ~~(3)~~ Whether or not authorized by the village charter,
17 the village council may adopt an ordinance that designates a vio-
18 lation of the ordinance as a municipal civil infraction and pro-
19 vides a civil fine for that violation. An ordinance may not des-
20 ignate a violation as a municipal civil infraction if that viola-
21 tion may be designated as a civil infraction under
22 subsection (1). ~~or as a marine law civil infraction under~~
23 ~~subsection (2).~~ A statute may provide that a violation of a spe-
24 cific type of ordinance is a municipal civil infraction whether
25 or not the ordinance designates the violation as a municipal
26 civil infraction.

2 municipal civil infraction if that act or omission constitutes a
3 crime under any of the following:

4 (a) Article 7 or section 17766a of the public health code,

6 to 333.7545 and 333.17766a of the Michigan Compiled Laws.
