



HOUSE BILL No. 5327

October 25, 1995, Introduced by Rep. Alley and referred to the Committee on Conservation, Environment and Great Lakes.

A bill to amend sections 273 and 451 of Act No. 354 of the Public Acts of 1993, entitled "Railroad code of 1993," being sections 462.273 and 462.451 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Sections 273 and 451 of Act No. 354 of the
2 Public Acts of 1993, being sections 462.273 and 462.451 of the
3 Michigan Compiled Laws, are amended to read as follows:

4 Sec. 273. (1) Except in the case of a right-of-way desig-
5 nated as a demonstration snowmobile trail in section ~~15 of Act~~
6 ~~No. 74 of the Public Acts of 1968, being section 257.1515~~ 82126
7 OF PART 821 (SNOWMOBILES) OF THE NATURAL RESOURCES AND
8 ENVIRONMENTAL PROTECTION ACT, ACT NO. 451 OF THE PUBLIC ACTS OF
9 1994, BEING SECTION 324.82126 of the Michigan Compiled Laws, a

1 person shall not walk, ride, drive, or be upon or along the
2 right-of-way or yard of a railroad company operating its lines
3 within this state, or go upon or cross the right-of-way or yard
4 at a place other than a public or private crossing, unless having
5 first obtained written permission from the owner or occupant
6 railroad, its agent or servant.

7 (2) For purposes of this section, "right-of-way" means the
8 track or roadbed owned by a railroad and that property owned by a
9 railroad which is located on either side of its tracks and which
10 is readily recognizable to a reasonable person as being railroad
11 property or is reasonably identified as such by fencing, the
12 existence of railroad tracks, or appropriate signs.

13 (3) A person shall not be upon, enter, or damage any build-
14 ings, rolling stock, or equipment of any railway company operat-
15 ing its lines within this state.

16 (4) This section shall not apply to any of the following:

17 (a) Passengers on trains or employees of a railroad company
18 while engaged in the performance of the duties of their
19 employment.

20 (b) An authorized representative of the railroad employees.

21 (c) A person going upon the right-of-way or tracks to save
22 human life or to protect property.

23 (d) A person going or being upon or in the station grounds
24 or depot of the railroad company as a passenger or for the pur-
25 pose of transacting business with the railroad company.

26 (e) A person, members of his or her family, or his or her
27 employees going upon the right-of-way or tracks for the purpose

1 of crossing from 1 part to another of a farm he or she may own or
2 lease, where the farm lies on both sides of the right-of-way.

3 (f) A person having written permission to go upon the
4 right-of-way or tracks granted by the railroad company, a person
5 using officially abandoned ~~right-of-ways~~ RIGHTS-OF-WAY for rec-
6 reational purposes, the Michigan public service commission, the
7 state transportation department, the interstate commerce commis-
8 sion, or the federal railroad administration.

9 (g) A registered land surveyor or his or her employees for
10 the purpose of making land surveys.

11 (5) A person who violates this section is guilty of a misde-
12 meanor punishable by imprisonment for not more than 30 days, or
13 by a fine of not more than \$100.00, or both.
