

HOUSE BILL No. 5370

November 7, 1995, Introduced by Reps. Galloway, Kukuk, Hill, Ryan, Perricone, Bush, Geiger, McManus, Jamian, Gustafson, Hammerstrom, Jellema, Rhead, Weeks and Bobier and referred to the Committee on Local Government.

A bill to amend section 4 of chapter VI of Act No. 3 of the Public Acts of 1895, entitled as amended
"The general law village act,"
as amended by Act No. 346 of the Public Acts of 1982, being section 66.4 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Section 4 of chapter VI of Act No. 3 of the
- 2 Public Acts of 1895, as amended by Act No. 346 of the Public Acts
- 3 of 1982, being section 66.4 of the Michigan Compiled Laws, is
- 4 amended to read as follows:
- 5 CHAPTER VI
- 6 Sec. 4. (1) Within 15 days after the passage of an ordi-
- 7 nance, the CLERK SHALL PUBLISH THE ordinance or a synopsis of the
- 8 ordinance -shall be published in a newspaper circulated in the
- 9 village. Immediately after -publication THE ORDINANCE IS

- 1 PUBLISHED, the clerk shall enter in the record of ordinances, in
- 2 a blank space to be left for that THIS purpose under the record
- 3 of the ordinance, a SIGNED certificate -under the clerk's hand,
- 4 stating the time and places of the publication DATE AND NEWSPA-
- 5 PER IN WHICH THE ORDINANCE WAS PUBLISHED. The certificate shall
- 6 be IS prima facie evidence of the due LEGAL publication of the
- 7 ordinance or the synopsis.
- 8 (2) A village may adopt a plumbing code, electrical code,
- 9 or building code which has been promulgated by this state, by a
- 10 department, board, or other agency of this state, or by an organ-
- 11 ization or association which is organized or conducted for the
- 12 purpose of developing a STATUTE OF THIS STATE, A RULE PROMUL-
- 13 GATED BY AN AGENCY OF THIS STATE, OR A RECOGNIZED STANDARD OFFI-
- 14 CIAL OR UNOFFICIAL code by reference -to the code in an adopting
- 15 ordinance and without publishing the STATUTE, RULE, OR code in
- 16 full. IF AN ORDINANCE ADOPTS BY REFERENCE A STATUTE OF THIS
- 17 STATE OR A RULE PROMULGATED BY AN AGENCY OF THIS STATE, THE ORDI-
- 18 NANCE MAY INCORPORATE FUTURE AMENDMENTS OR REVISIONS OF THE STAT-
- 19 UTE OR RULE BY EXPLICITLY PROVIDING THAT FUTURE AMENDMENTS OR
- 20 REVISIONS ARE INCORPORATED BY REFERENCE WHEN, OR A SPECIFIED
- 21 PERIOD OF TIME AFTER, THEY TAKE EFFECT IN THIS STATE. The
- 22 STATUTE, RULE, OR code shall be clearly identified in the
- 23 ADOPTING ordinance, and a statement of the purpose of the
- 24 STATUTE, RULE, OR code shall be published with the adopting
- 25 ordinance. Printed copies of the STATUTE, RULE, OR code shall be
- 26 kept in the office of the village clerk, available for inspection
- 27 by and distribution to the public. at all times. The NEWSPAPER

- 1 publication in the newspaper OF THE ORDINANCE shall contain a
- 2 notice to the effect that a complete copy of the STATUTE, RULE,
- 3 OR code is available for INSPECTION BY AND DISTRIBUTION TO THE
- 4 public -use and inspection at the office of the village clerk.
