

HOUSE BILL No. 5489

December 14, 1995, Introduced by Reps. Galloway, McBryde, Jamian, Hammerstrom, Byl, Weeks, Rhead, Walberg, Porreca, Baade, Curtis, Munsell, Lowe and Llewellyn and referred to the Committee on House Oversight and Ethics.

A bill to amend section 3a of Act No. 317 of the Public Acts of 1968, entitled as amended

"An act relating to the conduct of public servants in respect to governmental decisions and contracts with public entities; to provide penalties for the violation of this act; to repeal certain acts and parts of acts; and to validate certain contracts," as added by Act No. 9 of the Public Acts of 1992, being section 15.323a of the Michigan Compiled Laws; and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Section 3a of Act No. 317 of the Public Acts of
- 2 1968, as added by Act No. 9 of the Public Acts of 1992, being

- (a) Prohibit public servants of a city, village, township,
- 2 or county -having WITH a population of less than 25,000 from
- 3 serving, with or without compensation, as emergency medical serv-
- 4 ices personnel as defined in section 20904 of the public health
- 5 code, Act No. 368 of the Public Acts of 1978, being
- 6 section 333.20904 of the Michigan Compiled Laws.
- 7 (b) Prohibit public servants of a city, village, township,
- 8 or county having WITH a population of less than 25,000 from
- 9 serving, with or without compensation, as a firefighter in that
- 10 city, village, township, or county if that firefighter is not any
- 11 of the following:
- (i) A full-time firefighter.
- (ii) A fire chief.
- (iii) A person who negotiates with the city, village, town-
- 15 ship, or county on behalf of the firefighters.
- (c) Limit the authority of the governing body of a city,
- 17 village, township, or county having WITH a population of less
- 18 than 25,000 to authorize a public servant to perform, with or
- 19 without compensation, other additional services for the unit of
- 20 local government.
- 21 (D) PROHIBIT PUBLIC SERVANTS OF THIS STATE FROM PURCHASING
- 22 AT A TAX SALE LANDS RETURNED AS DELINQUENT FOR TAXES UNDER THE
- 23 GENERAL PROPERTY TAX ACT, ACT NO. 206 OF THE PUBLIC ACTS OF 1893,
- 24 BEING SECTIONS 211.1 TO 211.157 OF THE MICHIGAN COMPILED LAWS.
