A bill to amend Act No. 451 of the Public Acts of 1994,
entitled
"Natural resources and environmental protection act,"
as amended, being sections 324.101 to 324.90106 of the Michigan
Compiled Laws, by adding section 48702b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Act No. 451 of the Public Acts of 1994, as
2 amended, being sections 324.101 to 324.90106 of the Michigan
3 Compiled Laws, is amended by adding section 48702b to read as
4 follows:

5 SEC. 48702B. (1) UPON PETITION OF AN AGGRIEVED PERSON OR A
6 PERSON WHO REASONABLY MAY BE AGGRIEVED BY A VIOLATION OF SECTION
7 48702A, A COURT OF COMPETENT JURISDICTION, UPON A SHOWING THAT A
8 PERSON WAS ENGAGED IN AND THREATENS TO CONTINUE TO ENGAGE IN
9 ILLEGAL CONDUCT UNDER SECTION 48702A, MAY ENJOIN THAT CONDUCT.

1 (2) A PERSON WHO VIOLATES SECTION 48702A IS GUILTY OF A
2 MISDEMEANOR, PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN
3 90 DAYS, OR A FINE OF NOT LESS THAN \$500.00 OR MORE THAN
4 \$1,000.00, OR BOTH, AND THE COSTS OF PROSECUTION. IN ADDITION,
5 ANY PERMIT OR LICENSE ISSUED BY THE DEPARTMENT AUTHORIZING THE
6 PERSON TO TAKE ANIMALS SHALL BE REVOKED.

7 (3) SECTION 48702A DOES NOT APPLY TO A PEACE OFFICER WHILE
8 THE PEACE OFFICER PERFORMS HIS OR HER LAWFUL DUTIES.

9 Section 2. This amendatory act shall not take effect unless
10 Senate Bill No. 963 or House Bill No. ____ (request no. 07399'96)
11 of the 88th Legislature is enacted into law.
