

## **HOUSE BILL No. 5917**

May 30, 1996, Introduced by Reps. Bennane and DeMars and referred to the Committee on Health Policy.

A bill to amend sections 16131, 16205, and 16263 of Act No. 368 of the Public Acts of 1978, entitled as amended "Public health code,"

section 16205 as amended by Act No. 290 of the Public Acts of 1986 and sections 16131 and 16263 as amended by Act No. 126 of the Public Acts of 1995, being sections 333.16131, 333.16205, and 333.16263 of the Michigan Compiled Laws; and to add section 16322 and part 165.

- 22 Sec. 16205. (1) A board -which THAT requires evidence of
- 23 attendance at educational programs as a condition to license OR
- 24 REGISTRATION renewal may waive those requirements if, upon writ-
- 25 ten application, the board finds the failure of the licensee OR
- 26 REGISTRANT to attend was due to the licensee's disability,
- 27 military service, absence from the continental United States, or

- 1 a circumstance beyond the HIS OR HER control of the licensee
- 2 which THAT the board considers good and sufficient.
- 3 (2) A board may promulgate rules to establish a system of
- 4 assessing the continued competence of licensees OR REGISTRANTS as

  11 completion of training, received a 2-year associate of science
  12 degree as an orthopedic physician's assistant before January 1,
  13 1977, may use the title "orthopedic physician's assistant"
  14 whether or not the person is licensed under this article.

- 22 SEC. 16501. (1) AS USED IN THIS PART:
- 23 (A) "ACUPUNCTURE" MEANS THE INSERTION AND MANIPULATION OF
  24 NEEDLES ON THE SURFACE OF THE HUMAN BODY AND THE USE OF ORIENTAL
  25 MEDICINE AT SPECIFIC LOCATIONS ON THE HUMAN BODY FOR THE

- 5 IN SECTION 16524 (2), IS REGISTERED UNDER THIS PART.

- 7 TRATION OF HERBS OF ANIMAL, VEGETABLE, OR MINERAL ORIGIN FOR
- 8 HEALTH MAINTENANCE AND THE TREATMENT OF EFFECTS OF DISEASE.
- 9 (D) "BREATHING AND EXERCISE TECHNIQUES" MEANS THE USE OF 10 TECHNIQUES OF THERAPEUTIC BREATHING AND EXERCISE.
- 11 (E) "COLD PACKS" MEANS THE APPLICATION OF COLD PACKS AND ICE
- 12 TO SPECIFIC LOCATIONS ON THE HUMAN BODY TO REDUCE HEAT CONDITIONS
- 13 OR INFLAMMATION IN SURFACE TISSUES OF THE HUMAN BODY.
- 14 (F) "CUPPING" MEANS THE HEATING OF AIR OR THE MECHANICAL
- 15 CREATION OF SUCTION IN A CUP, APPLICATION TO SPECIFIC LOCATIONS
- 16 ON THE HUMAN BODY TO INDUCE LOCAL VASODILATION AND MECHANICAL
- 17 EXPANSION OF UNDERLYING TISSUE.
- (G) "DIETARY, NUTRITIONAL, AND LIFESTYLE COUNSELING" MEANS
- 19 IN-DEPTH PATIENT INTERVIEWS AND COUNSELING TO DETERMINE WHETHER
- 20 POOR DIETARY, NUTRITIONAL, OR LIFESTYLE PRACTICES ARE A FACTOR IN
- 21 A PATIENT'S ILLNESS AND TO EDUCATE TOWARD A HEALTHIER LIFESTYLE.
- 22 (H) "ELECTROACUPUNCTURE INCLUDING ELECTRODERMAL ASSESSMENT"
- 23 MEANS THE USE OF ELECTRONIC BIOFEEDBACK, AND ELECTROSTIMULATION
- 24 INSTRUMENTS.
- 25 (I) "ION PUMPING CORDS" MEANS THE APPLICATION OF WIRES CON-
- 26 TAINING DIODES TO ACUPUNCTURE NEEDLES THAT HAVE BEEN PLACED ON
- 27 THE HUMAN BODY.

- 1 (J) "MAGNETS" MEANS THE APPLICATION OF MAGNETS TO SPECIFIC
- 2 LOCATIONS ON THE HUMAN BODY.
- 3 (K) "MERIDIAN THERAPY" MEANS AN ASSESSMENT OR TREATMENT
- 4 DEVICE FOR USE WITH ACUPUNCTURE MERIDIANS.
- 5 (1) "MOXIBUSTION" MEANS THE USE OF HEAT AT SPECIFIC LOCA-
- 6 TIONS ON THE HUMAN BODY FOR THE PREVENTION OR CORRECTION OF DIS-
- 7 EASE, INJURY, PAIN, OR OTHER CONDITION.
- 8 (M) "ORIENTAL MEDICINE" MEANS THE DISTINCT SYSTEM OF PRIMARY
- 9 HEALTH CARE THAT USES ALL DIAGNOSTIC AND TREATMENT TECHNIQUES OF
- 10 ORIENTAL MEDICINE, BOTH TRADITIONAL AND MODERN, FOR THE PREVEN-
- 11 TION OR CORRECTION OF DISEASE, ILLNESS, INJURY, PAIN, OR OTHER
- 12 CONDITION. ORIENTAL MEDICINE INCLUDES, BUT IS NOT LIMITED TO,
- 13 ALL OF THE FOLLOWING:
- (i) MOXIBUSTION.

- 1 SEC. 16503. THIS PART DOES NOT APPLY TO A CERTIFIED,
- 2 LICENSED, OR STATUTORILY RECOGNIZED MEMBER OF ANOTHER PROFESSION
- 3 WHO PRACTICES HIS OR HER PROFESSION AS AUTHORIZED BY LAW SO LONG
- 4 AS THE INDIVIDUAL DOES NOT HOLD HIMSELF OR HERSELF OUT AS AN
- 5 ACUPUNCTURIST REGISTERED UNDER THIS ARTICLE.
- 6 SEC. 16511. AFTER RULES ARE PROMULGATED UNDER
- 7 SECTION 16145, AN INDIVIDUAL SHALL NOT USE THE TITLE
- 8 "ACUPUNCTURIST" OR "REGISTERED ACUPUNCTURIST" UNLESS HE OR SHE IS
- 9 REGISTERED UNDER THIS ARTICLE.
- 10 SEC. 16512. (1) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION
- 11 (2), AN ACUPUNCTURIST SHALL PRACTICE ONLY UPON THE REFERRAL OF A

- 21 (3) AN ACUPUNCTURIST SHALL NOT ATTEMPT TO IDENTIFY UNDERLY-
- 22 ING MEDICAL PROBLEMS OR ETIOLOGIES OR ESTABLISH MEDICAL
- 23 DIAGNOSES.
- 24 SEC. 16521. THE MICHIGAN BOARD OF ACUPUNCTURE IS CREATED IN
- 25 THE DEPARTMENT AND SHALL CONSIST OF THE FOLLOWING 5 VOTING MEM-
- 26 BERS WHO MEET THE REQUIREMENTS OF PART 161:

- 1 (A) THREE INDIVIDUALS WHO MEET THE REQUIREMENTS OF
- 2 SECTION 16135(2) AND ARE NOT LICENSED UNDER PART 170 OR 175.
- 3 (B) ONE PHYSICIAN LICENSED UNDER PART 170 OR 175.

- 5 SEC. 16523. THE BOARD SHALL ISSUE A REGISTRATION TO AN

- 7 PROMULGATED AS DESCRIBED IN SECTION 16524(1) AND PASSES AN EXAMI-
- 8 NATION ADOPTED AND CERTIFIED BY THE NATIONAL COMMISSION FOR THE
- 9 CERTIFICATION OF ACUPUNCTURISTS AND ACCEPTED BY THE BOARD,
- 10 INCLUDING THE WRITTEN AND PRACTICAL COMPONENTS AND THE CLEAN
- 11 NEEDLE TECHNIQUES.
- 12 SEC. 16524. (1) IN PROMULGATING RULES THAT ESTABLISH
- 13 REQUIREMENTS FOR REGISTRATION UNDER SECTION 16145, THE BOARD MAY
- 14 ADOPT BY REFERENCE REQUIREMENTS SET BY THE NATIONAL COMMISSION
- 15 FOR THE CERTIFICATION OF ACUPUNCTURISTS OR ITS SUCCESSOR
- 16 ORGANIZATION. THE BOARD SHALL NOT PROMULGATE RULES THAT DIMINISH
- 17 COMPETITION OR EXCEED THE MINIMUM LEVEL OF REGULATION NECESSARY
- 18 TO PROTECT THE PUBLIC.
- (2) FOR A PERIOD NOT TO EXCEED 2 YEARS AFTER THE BOARD

- 22 ICATE OF REGISTRATION WITHOUT EXAMINATION TO AN INDIVIDUAL WHO
- 23 HAS BEEN AN ACUPUNCTURIST IN THIS STATE FOR A MINIMUM OF 3 OUT OF
- 24 THE 5 YEARS IMMEDIATELY PRECEDING THE DATE OF THE INDIVIDUAL'S
- 25 APPLICATION FOR REGISTRATION. HOWEVER, THE BOARD SHALL NOT RENEW

- SEC. 16527. (1) THE BOARD SHALL PROMULGATE RULES TO ESTAB-
- 4 LISH A SYSTEM OF ASSESSING THE CONTINUED COMPETENCE OF REGIS-
- 5 TRANTS AS A CONDITION OF REGISTRATION RENEWAL.
- (2) THE BOARD SHALL REQUIRE, AT A MINIMUM, AS PART OF THE 6
- 7 RULES PROMULGATED UNDER SUBSECTION (1), THAT EACH REGISTRANT COM-
- 8 PLETE NOT LESS THAN 30 HOURS OF CONTINUING EDUCATION EACH RENEWAL
- 9 PERIOD. THE BOARD SHALL ENFORCE THE CONTINUING EDUCATION
