



# HOUSE BILL No. 5941

June 6, 1996, Introduced by Reps. A bill to amend Act No. 218 of the Public Acts of 1956, entitled as amended "The insurance code of 1956," as amended, being sections 500.100 to 500.8302 of the Michigan Compiled Laws, by adding section 3406f.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1 Section 1. Act No. 218 of the Public Acts of 1956, as  
2 amended, being sections 500.100 to 500.8302 of the Michigan  
3 Compiled Laws, is amended by adding section 3406f to read as  
4 follows:

5 SEC. 3406F. (1) SUBJECT TO DOLLAR LIMITS, DEDUCTIBLES, AND  
6 COINSURANCE PROVISIONS THAT ARE NOT LESS FAVORABLE THAN THOSE FOR  
7 PHYSICAL ILLNESS GENERALLY, AN INSURER THAT DELIVERS, ISSUES FOR  
8 DELIVERY, OR RENEWS IN THIS STATE AN EXPENSE-INCURRED HOSPITAL,  
9 MEDICAL, OR SURGICAL POLICY OR CERTIFICATE SHALL PROVIDE COVERAGE

1 FOR AND ACCESS TO EVALUATION AND TREATMENT OF INTRACTABLE PAIN AT  
2 CENTERS FOR ADVANCED CARE OR OTHER SPECIALIZED CENTERS OF PAIN  
3 MANAGEMENT AND APPROVED BY THE MICHIGAN COMMISSION ON PAIN.

4 (2) AS USED IN THIS SECTION, "CENTER FOR ADVANCED CARE",  
5 "INTRACTABLE PAIN", AND "MICHIGAN COMMISSION ON PAIN" MEAN THOSE  
6 TERMS AS DEFINED IN SECTION 18901 OF THE PUBLIC HEALTH CODE, ACT  
7 NO. 368 OF THE PUBLIC ACTS OF 1978, BEING SECTION 333.18901 OF  
8 THE MICHIGAN COMPILED LAWS.

9 Section 2. This amendatory act shall not take effect unless  
10 Senate Bill No. \_\_\_\_\_ or House Bill No. 5944 (request  
11 no. 07695'96) of the 88th Legislature is enacted into law.
