A bill to amend Act No. 368 of the Public Acts of 1978, entitled as amended

"Public health code,"

as amended, being sections 333.1101 to 333.25211 of the Michigan Compiled Laws, by adding section 21054y.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 368 of the Public Acts of 1978, as
- 2 amended, being sections 333.1101 to 333.25211 of the Michigan
- 3 Compiled Laws, is amended by adding section 21054y to read as
- 4 follows:
- 5 SEC. 21054Y. SUBJECT TO DOLLAR LIMITS, DEDUCTIBLES, AND
- 6 COINSURANCE PROVISIONS THAT ARE NOT LESS FAVORABLE THAN THOSE FOR
- 7 PHYSICAL ILLNESS GENERALLY, A HEALTH MAINTENANCE ORGANIZATION
- 8 SHALL PROVIDE, IN EACH GROUP AND INDIVIDUAL CONTRACT, COVERAGE
- 9 FOR AND ACCESS TO EVALUATION AND TREATMENT OF INTRACTABLE PAIN AT

- 1 CENTERS FOR ADVANCED CARE OR OTHER SPECIALIZED CENTERS OF PAIN
- 2 MANAGEMENT APPROVED BY THE MICHIGAN COMMISSION ON PAIN. AS USED
