

## **HOUSE BILL No. 6117**

September 25, 1996, Introduced by Rep. Law and referred to the Committee on Insurance.

A bill to amend section 9 of Act No. 35 of the Public Acts of 1951, entitled as amended

"An act to authorize intergovernmental contracts between municipal corporations; to authorize any municipal corporation to contract with any person or any municipal corporation to furnish any lawful municipal service to property outside the corporate limits of the first municipal corporation for a consideration; to prescribe certain penalties; to authorize contracts between municipal corporations and with certain nonprofit public transportation corporations to form group self-insurance pools; and to prescribe conditions for the performance of those contracts,"

as added by Act No. 138 of the Public Acts of 1982, being section 124.9 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Section 9 of Act No. 35 of the Public Acts of
- 2 1951, as added by Act No. 138 of the Public Acts of 1982, being
- 3 section 124.9 of the Michigan Compiled Laws, is amended to read
- 4 as follows:

- Sec. 9. (1) A group self-insurance pool shall be deemed
- 2 IS a self-insurer for motor vehicle security under section 3101
- 3 of the insurance code of 1956, Act No. 218 of the Public Acts of

- 5 Compiled Laws, and section 531 of the Michigan vehicle code, Act

- 8 motor vehicle self-insurance provided by the pool -shall be
- 9 deemed to meet the requirements of security as required by those

- 12 required.
- (2) A group self-insurance pool providing motor vehicle
- 14 security under this section shall become a member of the cata-
- 15 strophic claims association created by section 3104 of the
- 16 insurance coder 3183 OF Act No. 218 of the Public Acts of 1956,
- 17 -us-umended, being section -500.3104 500.3183 of the Michigan
- 18 Compiled Laws.
- Section 2. This amendatory act shall take effect January 1,
- 20 1996.
