



SENATE BILL No. 256

February 14, 1995, Introduced by Senators STEIL, ROGERS, DE GROW, KOIVISTO, GOUGEON, STILLE, SCHUETTE, BYRUM and SHUGARS and referred to the Committee on Human Resources, Labor and Veterans Affairs.

A bill to amend the title and section 5 of Act No. 214 of the Public Acts of 1899, entitled as amended

"An act to provide relief outside of the soldiers' home for honorably discharged indigent soldiers, sailors, marines, nurses and members of women's auxiliaries and the indigent wives, widows and minor children of such indigent or deceased soldiers, sailors, marines, nurses and members of women's auxiliaries, and to repeal certain acts and parts of acts,"

being section 35.25 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. The title and section 5 of Act No. 214 of the
2 Public Acts of 1899, being section 35.25 of the Michigan Compiled
3 Laws, are amended to read as follows:

6 Sec. 5. (1) ~~Said~~ EACH soldiers' relief commission shall
 7 ~~make to the board of supervisors, at its October session in each~~
 8 ~~year, a full report of its doings and the~~ PROVIDE THE COUNTY
 9 BOARD OF COMMISSIONERS AND THE BOARD OF TRUSTEES OF THE MICHIGAN
 10 VETERANS' TRUST FUND AN ANNUAL REPORT THAT IDENTIFIES ALL OF THE
 11 FOLLOWING:

12 (A) THE ACTIVITIES OF THAT COMMISSION DURING THE 1-YEAR
 13 PERIOD IMMEDIATELY PRECEDING THE DATE OF THE REPORT.

14 (B) THE amount of relief money THAT COMMISSION HAS on hand
 15 ~~, the~~ ON THE DATE OF THE REPORT.

16 (C) THE amount OF RELIEF MONEY expended BY THAT COMMISSION
 17 during the ~~year~~ 1-YEAR PERIOD IMMEDIATELY preceding ~~, and~~ the
 18 DATE OF THE REPORT.

19 (D) THE amount estimated ~~for~~ TO BE SPENT BY THAT COMMIS-
 20 SION DURING the ~~year ensuing, and such~~ 1-YEAR PERIOD IMMEDI-
 21 ATELY FOLLOWING THE DATE OF THE REPORT.

22 (E) ANY further information and suggestions ~~as they~~ THAT
 23 THE COMMISSION may consider necessary ~~to~~ FOR the discharge of
 24 ~~their~~ ITS duties under this act.

25 (2) THE ANNUAL REPORT DESCRIBED IN SUBSECTION (1) SHALL BE
 26 PROVIDED TO THE COUNTY BOARD OF COMMISSIONERS AT THAT BOARD'S
 27 OCTOBER SESSION EACH YEAR.

1 (3) AS USED IN THIS SECTION, "BOARD OF TRUSTEES OF THE
2 MICHIGAN VETERANS' TRUST FUND" MEANS THE ENTITY CREATED UNDER
3 SECTION 3 OF ACT NO. 9 OF THE PUBLIC ACTS OF THE FIRST EXTRA SES-
4 SION OF 1946, BEING SECTION 35.603 OF THE MICHIGAN COMPILED LAWS.

5 Section 2. This amendatory act shall not take effect unless

7 of the 88th Legislature is enacted into law.
