

SENATE BILL No. 306

EXECUTIVE BUDGET

February 16, 1995, Introduced by Senators GEAKE, CONROY and GAST and referred to the Committee on Appropriations.

A bill to make appropriations for the department of mental health and certain state purposes related to mental health for the fiscal year ending September 30, 1996; to provide for the expenditure of such appropriations; to create funds; to provide for reports; to prescribe the powers and duties of certain local and state agencies and departments; and to provide for disposition of fees and other income received by the various state agencies.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 101. There is appropriated for the department of mental health
- 2 for the fiscal year ending September 30, 1996, from the following funds:

22	Sec. 201. The expenditures and funding sources authorized under
23	this bill are subject to the management and budget act, Act No. 431 of
24	the Public Acts of 1984, being sections 18.1101 to 18.1594 of the
25	Michigan Compiled Laws.
26	Sec. 202. (1) The amounts transferred from one fund to another fund
27	shall be authorized pursuant to annual appropriations within the
28	departments responsible for each fund's appropriations.

- 1 (2) Funds for which the state is acting as the custodian or agent
- 2 are not subject to annual appropriation.
- 3 Sec. 203. (1) The number of permanent career FTE employees shall
- 4 not exceed the number listed in section 101 of this bill unless an
- 5 exception has been granted by the director of the department of
- 6 management and budget. Exceptions shall only be given if failure to
- 7 fill the positions will result in rendering the department unable to
- 8 deliver basic services, cause a loss of revenue to the state, or
- 9 necessitate additional expenditures that exceed savings from
- 10 maintaining a vacancy. On the fifteenth of each month, the department
- 11 of management and budget shall report to the house and senate
- 12 appropriations committees and the governor any exceptions that have
- 13 been granted in the preceding month.
- 14 (2) Permanent career appointments shall be used as defined by the
- 15 civil service commission.
- 16 (3) The number of FTEs to be funded by each individual line item
- 17 amount shall be determined by the department within the overall limit
- 18 on permanent career FTEs for the department.
- 19 Sec. 204. (1) Any federal, local, private, or state restricted
- 20 funds received by a department in addition to the amount appropriated
- 21 in section 101, are appropriated.
- 22 (2) Funds appropriated in subsection (1) totalling less than
- 23 \$50,000.00 during the fiscal year from any one source may be expended
- 24 for the purposes for which the funds were made available. Receipt of
- 25 these funds shall be reported to the senate and house appropriations
- 26 committees and the house and senate fiscal agencies within thirty days
- 27 after the close of each fiscal quarter.
- 28 (3) Funds appropriated in subsection (1) totalling \$50,000.00 or
- 29 more during the fiscal year are not available for expenditure until

- 1 they have been transferred to another line item in this act through an
- 2 administrative transfer as defined in section 393(1) of Act No. 431 of
- 3 the Public Acts of 1984, as amended, being section 18.1393(1) of the
- 4 Michigan Compiled Laws.
- 5 Sec. 205. The department of civil service shall bill departments
- 6 and/or agencies at the end of the first fiscal guarter for the 1%
- 7 charges authorized by section 5 of Article XI of the State Constitution
- 8 of 1963. Payments shall be made for the total amount of the billing by
- 9 the end of the second fiscal quarter.
- 10 Sec. 206. As used in this act:
- 11 (a) "CMH" means community mental health.
- 12 (b) "CMH-Act 423 fund" means the fund described in section 310(b)
- 13 of the mental health code, Act No. 258 of the Public Acts of 1974,
- 14 being section 330.1310 of the Michigan Compiled Laws.
- 15 (c) "DAG" means the United States department of agriculture.
- (d) "DAG-FNS" means the DAG, food and nutrition services.
- (e) "DED" means the United States department of education.
- 18 (f) "DED-OSERS" means the DED, office of special education and
- 19 rehabilitative services.
- 20 (g) "Department" means the department of mental health.
- 21 (h) "HHS" means the United States department of health and human
- 22 services.
- 23 (i) "HHS-ACF" means the HHS administration for children and
- 24 families.
- 25 (j) "HHS-HCFA" means the HHS health care financing administration.
- (k) "HHS-PHS-HRSA" means the HHS public health service, health
- 27 resources and services administration.
- 28 (1) "HHS-SAMSHA" means the HHS substance abuse and mental health
- 29 services administration.

- 1 (m) "IDG" means interdepartmental grant.
- 2 (n) "MDOC" means the Michigan department of corrections.
- 3 (o) "MDMB" means the Michigan department of management and budget.
- 4 (p) "MDPH" means the Michigan department of public health.
- 5 (q) "MDSS" means the Michigan department of social services.
- 6 (r) "Title XX" means title XX of the social security act, chapter
- 7 531, 49 Stat. 620, 42 U.S.C. 1397 to 1397f.
- 8 Sec. 207. (1) Each April 15, the department shall provide a report
- 9 to the department of management and budget, the chairpersons of the
- 10 senate and house appropriations committees, the senate and house fiscal
- 11 agencies, and the auditor general. The report shall contain all of the
- 12 following:
- (a) A description of the clients, services, funding, and
- 14 expenditures of each community mental health board including
- 15 information about per capita expenditure by client group.
- 16 (b) Information about the reimbursement eligibility of clients of
- 17 the department and community mental health boards.
- 18 (2) The department shall provide a report_on contractual services
- 19 to the department of management and budget and to the chairpersons of
- 20 the senate and house appropriations committees each month. The report
- 21 shall be based on the monthly civil service statewide contracted
- 22 services report required by section 281 of the management and budget
- 23 act, Act No. 431 of the Public Acts of 1984, being section 18.1281 of
- 24 the Michigan Compiled Laws. The report shall provide the name of the
- 25 contractor, the dollar value of the contract, description, and location
- 26 of the service to be provided, and justification for the contract.
- 27 Sec. 208. From the funds appropriated in section 101 such payments
- 28 of wages and salaries as are made for classified state employees shall
- 29 be made in accordance with applicable laws, rules, and regulations of

- 1 the civil service commission. The funds identified in section 101 for
- 2 unclassified employees are based upon prior year levels adjusted
- 3 consistent with pay plan recommendations for non-exclusively
- 4 represented employees (NEREs) of the civil service commission, except
- 5 in the case of department directors and heads of type I agencies, where
- 6 the funds provided are in an amount equal the standards established by
- 7 the civil service commission as the maximum pay for state executive
- 8 service classification 20 and state executive service classification 18
- 9 employees, respectively. Although the funds identified in section 101
- 10 for unclassified employees are based upon the standards set forth
- 11 above, the exact salaries of individual unclassified employees shall be
- 12 set by the appointing authority, not to exceed the state executive
- 13 service classification 20 maximum payment in the case of a department
- 14 director, or the state executive service classification 18 maximum
- 15 payment in the case of a head of a type I agency. The salaries of
- 16 individual unclassified employees shall be a matter of public record.

17 EXECUTIVE OFFICE

- 18 Sec. 301. Funds appropriated in section 101 from the central fund
- 19 for acquiring additional federal and private funds shall not be
- 20 expended until the grant money is actually authorized by the grantor.
- 21 Funds accepted under this section shall not be authorized if the
- 22 receipt of the funds mandates a commitment for state funding at a
- 23 future date.
- Sec. 302. (1) In funding staff in the financial support division,
- 25 reimbursement, and billing and collection sections, priority shall be
- 26 given to obtaining third party payments for services.
- 27 (2) The department shall continue a revenue recapture project to
- 28 generate additional revenues from third parties related to cases which
- 29 have been closed or are inactive. Revenues collected through project

- 1 efforts are appropriated to the department for departmental costs and
- 2 contractual fees associated with these retroactive collections and to
- 3 improve ongoing departmental reimbursement management functions so that
- 4 the need for retroactive collections will be reduced or eliminated.
- 5 Sec. 303. The department's ability to satisfy appropriation
- 6 deductions in section 101 shall not be limited to collections and
- 7 accruals pertaining to services provided in fiscal year 1995-96, but
- 8 shall also include reimbursements, refunds, adjustments, and
- .9 settlements from prior years.
- 10 Sec. 304. (1) With the approval of the department of management and
- 11 budget and senate and house appropriations subcommittees on mental
- 12 health, the director of the department may establish a discretionary
- 13 fund not to exceed 5% of the sum of the amounts of funds appropriated
- 14 in section 101 for the operation and support of executive programs,
- 15 community mental health, institutional operations, residential
- 16 services, and community mental health medicaid revenues.
- 17 (2) The director of the department may allocate expenditure
- 18 authorization amounts from the discretionary fund to departmental
- 19 institutions, community mental health boards, or for family support
- 20 subsidy payments. These funds may be used to achieve or maintain
- 21 certification for federal title XIX benefits, to equalize and maximize
- 22 staffing needs assessment project ratios, to expedite the transition of
- 23 responsibility for services to community mental health boards, and to
- 24 minimize the utilization of state inpatient services.
- 25 (3) The director of the department may also allocate revenue
- 26 amounts from the discretionary fund for HHS-HCFA, medicaid, DAG-FNS,
- 27 national school lunch program, first/third party revenues,
- 28 miscellaneous revenues, audit exception/cost settlement revenues, and
- 29 county match revenues allocated for state hospitals, centers, and

- 1 residential care into another revenue account listed in this section,
- 2 and into community mental health medicaid revenue accounts.
- 3 Sec. 305. Funds appropriated in section 101 for the mental health
- 4 advisory council may be used for member per diems of \$50.00 and other
- 5 council expenditures. Funds may also be used for the expenses of the
- 6 state mental health advisory council on deafness and other expenses for
- 7 councils established by the mental health code, Act No. 258 of the
- 8 Public Acts of 1974, being sections 330.1001 to 330.2106 of the
- 9 Michigan Compiled Laws.
- 10 Sec. 306. Unexpended and unencumbered amounts and accompanying
- 11 expenditure authorizations up to \$2,000,000.00 remaining on September
- 12 30, 1996 from pay telephone revenues and the amounts appropriated in
- 13 section 101 for gifts and bequests for patient living and treatment
- 14 environments shall be carried forward for one fiscal year. The purpose
- 15 of gifts and bequests for patient living and treatment environments and
- 16 pay telephone revenue is to use additional private funds to provide
- 17 specific enhancements for individuals residing at state operated
- 18 facilities. Use of the gifts and bequests shall be consistent with the
- 19 stipulation of the donor. The expected completion date for the use of
- 20 gifts and bequests donations is within three years unless otherwise
- 21 stipulated by the donor.
- Sec. 307. The department shall provide quarterly reports concerning
- 23 the department's revenue and expenditure status to the senate and house
- 24 appropriations subcommittees on mental health, the house and senate
- 25 fiscal agencies, and the department of management and budget.
- 26 Sec. 308. The specific amounts indicated in section 101 of this
- 27 act as restricted revenue for financing appropriations from first/third
- 28 parties, HHS-HCFA, medicaid, audit exception/cost settlement, CMH -
- 29 purchase of state services contracts and county revenues are estimates

- 1 of the proportion of the total amounts expected to be collected, and
- 2 the department may satisfy any individual restricted revenue deduct
- 3 amount from the total revenues of all of those revenue sources. A
- 4 report shall be provided by April 15 to the fiscal agencies and
- 5 department of management and budget on actual collections by revenue
- 6 source for each appropriation unit during the previous fiscal year.
- 7 Sec. 309. The funds appropriated in section 101 for prisoner mental
- 8 health services are for the assumption of responsibilities for prisoner
- 9 mental health in accordance with the interdepartmental plan developed
- 10 in cooperation with the department of corrections. The department is
- 11 authorized to receive and expend funds from the department of
- 12 corrections in addition to the appropriations in section 101 to fulfill
- 13 the obligations outlined in interdepartmental agreements.

14 COMMUNITY MENTAL HEALTH

- 15 Sec. 401. (1) Funds allocated in section 101 for community mental
- 16 health operations include the continuation of transportation services
- 17 funded 100% with state funds and include title XX transition grants.
- 18 (2) In addition to the funds appropriated in section 101 for
- 19 community mental health operations, all funds received by the CMH
- 20 boards in additional federal funds are appropriated. It is intended
- 21 that the community mental health boards maximize federal funding
- 22 sources. CMH boards shall retain, contingent upon actual earnings, the
- 23 amount of increased federal funds above the amounts authorized in the
- 24 billable services fiscal year ending September 30, 1995 contracts.
- 25 With the exception of transactions involving special medicaid adjuster
- 26 payments, state funding provided in each CMH board's contract shall not
- 27 be altered as a result of implementation of this section.
- 28 Sec. 402. (1) Funds appropriated in section 101 are intended to
- 29 support a system of comprehensive community mental health services

- 1 under the full authority and responsibility of local county community
- 2 mental health boards. The department shall ensure that each board
- 3 provides all of the following:
- 4 (a) A system of single entry and single exit.
- 5 (b) A comprehensive range of services that includes prevention and
- 6 that may include state provided acute and long-term inpatient and
- 7 residential care.
- 8 (c) The coordination of inpatient and outpatient hospital services
- 9 through agreements with state psychiatric hospitals and centers.
- 10 (d) Individualized plans of service that are sufficient to meet the
- 11 needs of individuals, including those discharged from psychiatric
- 12 hospitals or regional centers, and ensure the full range of recipient
- 13 needs is addressed through the board's program or through assistance
- 14 with locating and obtaining services.
- 15 (e) A system of case management to monitor and ensure the provision
- 16 of services consistent with the individualized plan of services or
- 17 supports.
- 18 (2) In partnership with community mental health boards, the
- 19 department shall establish a process to ensure the long-term viability
- 20 of a single entry and exit and locally controlled community mental
- 21 health system.
- 22 Sec. 403. (1) From funds appropriated in section 101, final
- 23 authorizations to community mental health boards shall be made upon the
- 24 execution of contracts between the department and community mental
- 25 health boards. The contracts shall contain an approved plan and budget
- 26 as well as policies and procedures governing the obligations and
- 27 responsibilities of both parties to the contracts.
- 28 (2) The funds appropriated in section 101 for the purchase of state
- 29 service contracts are for the purchase of state hospital and center

- 1 services, state administered community residential services, or for
- 2 approved community-based programs that reduce utilization of state
- 3 provided services. These funds shall be authorized to community mental
- 4 health boards based on estimates approved by the department as part of
- 5 the negotiated contract.
- 6 (3) Funds that are authorized to community mental health boards,
- 7 when used to purchase state services shall be provided to state
- 8 hospitals, centers, and placement agencies based on the per diem and
- 9 billing arrangements approved by the department in the negotiated
- 10 contract.
- 11 (4) The department may advance to each community mental health
- 12 board an amount not to exceed one-fourth of its estimated total
- 13 collections from medicaid and may establish a separate accounts
- 14 receivable for the total of these amounts. Advances made pursuant to
- 15 this subsection shall be repaid in the same fiscal year and before any
- 16 advance is provided for a subsequent year.
- 17 (5) Current billing and collection procedures for the net cost of
- 18 state provided services shall continue as specified in chapter 3 of the
- 19 mental health code, Act No. 258 of the Public Acts of 1974, being
- section 330.1300 to 330.1320 of the Michigan Compiled Laws.
- 21 (6) The department may access funds from the appropriation directly
- 22 for patients who have no county affiliation or for whom county charges
- 23 are exempted.
- 24 (7) The funds appropriated in section 101 from purchase of state
- 25 service contracts shall not result in increased costs to counties in
- 26 excess of the local match required under section 302 of the mental
- 27 health code, Act No. 258 of the Public Acts of 1974, being section
- 28 330.1302 of the Michigan Compiled Laws.
- Sec. 404. The funds appropriated in this act for community mental

- 1 health programs shall not be used to replace funds no longer available
- 2 because the local government or community mental health board reduced
- 3 its base of support for state and local mental health services, as
- 4 defined in chapter 2 of the mental health code, Act No. 258 of the
- 5 Public Acts of 1974, being sections 330.1200 to 330.1246 of the
- 6 Michigan Compiled Laws, below that of the previous year.
- 7 Sec. 405. (1) Funds appropriated in section 101 for community
- 8 mental health services may be reserved and carried forward into the
- 9 subsequent fiscal year by county community mental health boards as part
- 10 of a planned strategy to assist in dealing with base reductions and
- 11 unfunded economic increases.
- 12 (2) Funding reserved for base program reductions and unfunded
- 13 economic increases shall be limited to the difference between the cost
- 14 of continuing existing community mental health services in the
- 15 subsequent fiscal year and the level of funding available, and shall be
- 16 reserved as part of a plan submitted and approved by the department by
- 17 the end of the third quarter.
- 18 (3) Conditions under which funding may be reserved include all of
- 19 the following:
- 20 (a) The plan shall not alter or amend provisions of the contract
- 21 between the department and county community mental health boards
- 22 regarding protection of categorical funding.
- 23 (b) An expenditure made from a reserve account does not change a
- 24 board's base allocation or create a full year cost obligation for the
- 25 department.
- 26 (c) County community mental health boards shall report on the
- 27 amount and source of the carry forward and the amount and purpose of
- 28 expenditures from reserve accounts to the department.
- 29 (d) Funding carried forward and not used for the stated purpose

- 1 shall lapse to the state general fund.
- 2 Sec. 406. The amount appropriated in section 101 for community
- 3 mental health services is intended for funding of community mental
- 4 health service boards in accordance with contracts between the
- 5 department and the boards for the current fiscal year. The department
- 6 shall establish such total accounts payable and receivable amounts as
- 7 may be appropriate to represent the expected final state obligation for
- 8 all such contracts. After final review of the expenditure reports
- 9 required by the contracts, any amounts advanced to the board which are
- 10 returned to the department and any amounts paid to the boards in
- 11 accordance with the provisions of the contracts shall be considered to
- 12 be adjustments to the program expenditures for the prior fiscal year.
- 13 These prior year transactions shall be recorded in a separate account
- 14 established for that purpose. Community mental health programs prior
- 15 year revenue recognized in the current fiscal year may be restricted to
- 16 finance related prior year expenditures not previously recorded.
- 17 Sec. 407. Each CMH board shall maintain a waiting list of persons
- 18 waiting to receive mental health services who meet the following
- 19 criteria:
- 20 (a) The person, in person or by representation, is seeking mental
- 21 health services.
- 22 (b) The person has a condition for which the public mental health
- 23 system has a responsibility to provide mental health services.
- (c) The person is determined not to be in need of immediate,
- 25 emergency, or crisis intervention services.
- 26 (d) The person has agreed to be placed on the waiting list.
- 27 (e) The person's placement on the list is determined by the
- 28 priority of need, not by the time of arrival of the request for mental
- 29 health services.

- 1 Sec. 408. The funds appropriated in section 101 for expanding
- 2 community mental health services through the reduced utilization of
- 3 state facilities represent a transfer of resources resulting from
- 4 census and state hospital or center reductions. The appropriated
- 5 amount of \$24,735,100.00 is based upon full-year cost savings at state
- 6 hospitals and centers.
- 7 Sec. 409. (1) The local county match obligation appropriated in
- 8 section 101 may be met by CMH boards using funds appropriated to the
- 9 department of social services in a line item entitled special medicaid
- 10 adjuster payments, under the following conditions:
- 11 (a) The funds may only be used to meet county match requirements
- 12 that exceed the match requirement of the base year.
- (b) The base year is defined as the state fiscal year immediately
- 14 preceding the implementation of the special medicaid adjuster payment
- 15 program.
- 16 (2) All CMH boards receiving funds appropriated in section 101
- 17 through department-approved board contract spending plans may also use
- 18 the special medicaid adjuster payments provided they are used in
- 19 conformance with the approved spending plan. The special medicaid
- 20 adjuster payments do not require local or state match dollars and may
- 21 be carried forward for one year.
- 22 Sec. 410. Unexpended and unencumbered amounts and accompanying
- 23 expenditure authorization remaining on September 30, 1996 from the
- \$9,661,600.00 appropriated in section 101 for community demand may be
- 25 carried forward for two fiscal years as a work project. The purpose
- 26 and method of this work project is to respond to community demand by
- 27 providing community residential and alternative services to individuals
- 28 with developmental disabilities through community mental health boards.
- 29 The expected completion date is September 30, 1998.

COMMUNITY RESIDENTIAL SERVICES

- 2 Sec. 501. The funds appropriated in section 101 for community
- 3 residential services programs may be used for basic care in cases where
- 4 individuals are not eligible to receive social security benefits and
- 5 are not otherwise capable of supporting themselves out of their own
- 6 resources. Funds may be used for aftercare services or to prevent
- 7 admissions to state hospitals and centers through residential and
- 8 support services. Expenditures and allocations may be authorized for
- 9 community mental health boards and state hospitals, centers, and
- 10 placement agencies.

- 11 Sec. 502. The department shall not enter into new contracts with
- 12 private attorneys for legal services for the purposes of gaining and
- 13 maintaining occupancy to a specialized residential facility. The
- 14 department may enter into a contract with the protection and advocacy
- 15 service, authorized under section 931 of the mental health code, Act
- 16 No. 258 of the Public Acts of 1974, being section 330.1931 of the
- 17 Michigan Compiled Laws, or a similar organization to provide legal
- 18 services for purposes of gaining and maintaining occupancy in a
- 19 specialized residential facility which is under lease or contract with
- 20 the department or a community mental health board to provide services
- 21 to persons with mental illness or developmental disability. State
- 22 funds shall not be used for legal services to represent private
- 23 investors purchasing homes for these purposes.

24 INSTITUTIONAL SERVICES, HOSPITALS, AND CENTERS

- 25 Sec. 601. In addition to the amounts appropriated in section 101,
- 26 revenues from work activity centers and the sale of sheltered workshop
- 27 services and products are appropriated to be expended for supplies,
- 28 equipment, and other costs associated with the maintenance of the
- 29 sheltered workshop program, excluding costs of compensating state

- 1 classified employees. The unspent balance on the last day of the fiscal
- 2 year ending September 30, 1996 shall be carried forward into the
- 3 subsequent fiscal year. The funds carried forward shall be used for
- 4 supplies, equipment, and other costs associated with maintaining
- 5 sheltered workshop programs excluding the costs of compensating state
- 6 classified employees. The total estimated cost of the program is
- 7 \$1,250,000.00 and specific project expenditures are to be completed by
- 8 September 30, 1997.
- 9 Sec. 602. From funds appropriated for workers' compensation, the
- 10 department may make payments in lieu of workers' compensation payments
- 11 for wage/salary and related fringe benefits for employees who return to
- 12 work under limited duty assignments. Employees returning to work under
- 13 limited duty assignments and who are funded under this subsection will
- 14 be in addition to the facility's existing staffing authorization.
- 15 Sec. 603. In addition to expending funds appropriated in section
- 16 101 for state psychiatric hospitals, centers, and residential
- 17 services, the department is authorized, contingent upon the approval of
- 18 the department of management and budget, to do both of the following:
- 19 (a) Expend restricted funds earned above revenue appropriated for
- 20 community mental health purchase of state services contracts, first/
- 21 third party revenues, audit exception/cost settlement or title XIX
- 22 revenues excluding medicaid disproportionate share payment revenue or
- 23 other special medicaid adjuster payments.
- (b) Make interdepartmental transfers to the department of social
- 25 services equal to any medicaid disproportionate share payments or other
- 26 special medicaid adjuster payment received by the department.
