



SENATE BILL No. 416

March 16, 1995, Introduced by Senator VAUGHN and referred to the Committee on Government Operations.

A bill to amend section 492 of Act No. 116 of the Public Acts of 1954, entitled as amended "Michigan election law," as amended by Act No. 142 of the Public Acts of 1989, being section 168.492 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 492 of Act No. 116 of the Public Acts of
2 1954, as amended by Act No. 142 of the Public Acts of 1989, being
3 section 168.492 of the Michigan Compiled Laws, is amended to read
4 as follows:

5 Sec. 492. (1) ~~Every~~ A person who has the ~~following~~
6 qualifications of an elector AS PROVIDED IN THIS SECTION, or who
7 will have those qualifications at the next election, ~~or primary~~
8 ~~election, shall be entitled to~~ MAY be registered as an elector
9 in the township, city, or village in which he or she resides.

1 ~~The~~ EXCEPT AS PROVIDED IN SUBSECTION (2), THE person shall ~~be~~
2 MEET ALL OF THE FOLLOWING REQUIREMENTS:

3 (A) IS a citizen of the United States. ~~, not less than~~

4 (B) IS 18 years of age ~~,~~ OR OLDER.

5 (C) HAS BEEN a resident of ~~the~~ THIS state for ~~not less~~
6 ~~than~~ 30 days ~~,~~ and OR MORE.

7 (D) IS a resident of the township, city, or village on or
8 before the thirtieth day before the next ~~regular or special~~
9 ~~election or primary~~ election.

10 (2) A PERSON WHO IS A PUPIL IN A COURSE DESCRIBED IN SECTION
11 1166(2) OF THE SCHOOL CODE OF 1976, ACT NO. 451 OF THE PUBLIC
12 ACTS OF 1976, BEING SECTION 390.1166 OF THE MICHIGAN COMPILED
13 LAWS, MAY BE REGISTERED AS AN ELECTOR AS PROVIDED IN THAT SEC-
14 TION, EFFECTIVE UPON THE PERSON ATTAINING AGE 18. THE SECRETARY
15 OF STATE AND LOCAL ELECTION OFFICIALS SHALL COOPERATE AS NECES-
16 SARY WITH SCHOOL OFFICIALS TO IMPLEMENT THE OPPORTUNITY FOR REG-
17 ISTRATION PROVIDED IN SECTION 1166 OF ACT NO. 451 OF THE PUBLIC
18 ACTS OF 1976.

19 Section 2. This amendatory act shall not take effect unless
20 Senate Bill No. _____ or House Bill No. _____ (request
21 no. 00752'95) of the 88th Legislature is enacted into law.
