



# SENATE BILL No. 419

March 21, 1995, Introduced by Senators HONIGMAN, STEIL, GEAKE, CARL and ROGERS and referred to the Committee on Government Operations.

A bill to repeal Act No. 153 of the Public Acts of 1937, entitled

"An act relative to printing for the state of Michigan; to establish the requirements of responsible bidders; to prescribe penalties for the violation of the provisions of this act; and to repeal all acts and parts of acts inconsistent with the provisions of this act,"

being sections 24.61 to 24.62 of the Michigan Compiled Laws.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1 Section 1. Act No. 153 of the Public Acts of 1937, being  
2 sections 24.61 to 24.62 of the Michigan Compiled Laws, is  
3 repealed.

1 THE LEGISLATIVE SERVICE BUREAU, THE department of management and  
2 budget shall deliver or ~~mail~~ PROVIDE copies as follows:

3 (a) To the secretary of the senate, a sufficient number to  
4 supply each senator. ~~, standing committee, and the secretary.~~

5 (b) To the clerk of the house of representatives, a suffi-

8 ~~(c) To each member of the legislature, 1 copy at the~~  
9 ~~member's home address.~~

10 ~~(d) To the legislative service bureau, 1 copy for each~~  
11 ~~attorney on the bureau's staff.~~

12 ~~(e) To the department of the attorney general, 1 copy for~~  
13 ~~each division.~~

14 ~~(f) To each other state department, 3 copies.~~

15 ~~(g) To each county law library, bar association library, and~~  
16 ~~law school library in this state, 1 copy.~~

17 ~~(h) To other libraries throughout this state, 1 copy, upon~~  
18 ~~request.~~

19 ~~(i) Additional copies to an officer or agency of this state~~  
20 ~~and other governmental officers, agencies, and libraries approved~~  
21 ~~by the legislative service bureau; and additional copies of the~~  
22 ~~Michigan register for persons who subscribe to the publication as~~  
23 ~~provided in subsection (3).~~

24 (2) The copies of the Michigan register, the Michigan admin-  
25 istrative code, and the annual code supplement are for official  
26 use only by the agencies and persons prescribed in subsection  
27 (1), and they shall deliver them to their successors. ~~, except~~

1 ~~that members of the legislature may retain copies of the Michigan~~  
2 ~~register and the Michigan administrative code sent to their home~~  
3 ~~address. The department of management and budget shall send to~~  
4 ~~the home address of a new member of the legislature the current~~  
5 ~~volume of the Michigan register and a complete copy of the~~  
6 ~~Michigan administrative code. The department of management and~~  
7 ~~budget shall deliver to the state library the Michigan register,~~  
8 ~~the Michigan administrative code, and the annual supplement when~~  
9 ~~requested by the state library sufficient for the library's use~~  
10 ~~and for exchanges. The department of management and budget shall~~  
11 ~~hold additional copies for sale at a price not less than the pub-~~  
12 ~~lication and distribution costs which shall be determined by the~~  
13 ~~legislative service bureau.~~

14 (3) A person may subscribe to the Michigan register. The  
15 legislative service bureau shall determine a subscription price  
16 which shall not be more than the publication and distribution  
17 costs.
