

SENATE BILL No. 468

April 26, 1995, Introduced by Senator DE GROW and referred to the Committee on Government Operations.

A bill to amend section 19 of Act No. 382 of the Public Acts of 1972, entitled as amended

"Traxler-McCauley-Law-Bowman bingo act,"

as amended by Act No. 229 of the Public Acts of 1981, being section 432.119 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Section 19 of Act No. 382 of the Public Acts of
- 2 1972, as amended by Act No. 229 of the Public Acts of 1981, being
- 3 section 432.119 of the Michigan Compiled Laws, is amended to read
- 4 as follows:
- 5 Sec. 19. (1) Any EXCEPT AS PROVIDED IN SUBSECTION (2),
- 6 ANY other law providing a penalty or disability upon a person who
- 7 conducts or participates in a bingo game, millionaire party, or
- 8 charity game; who sells or possesses equipment used in conducting
- 9 bingo or a millionaire party; who permits bingo, a millionaire

- 1 party, or a charity game to be conducted on his or her premises;
- 2 or who does other acts in connection with bingo, a millionaire
- 3 party, or a charity game -shall DOES not apply to -such THAT
- 4 conduct -when IF done pursuant to this act or rules promulgated
- 5 under this act.
- 6 (2) A QUALIFIED ORGANIZATION LICENSED TO CONDUCT BINGO, A
- 7 MILLIONAIRE PARTY, OR A CHARITY GAME THAT IS ALSO REGISTERED AS
- 8 EITHER A BALLOT QUESTION COMMITTEE, CANDIDATE COMMITTEE, INDEPEN-
- 9 DENT COMMITTEE, POLITICAL COMMITTEE, POLITICAL PARTY COMMITTEE,
- 10 OR ANY OTHER COMMITTEE DEFINED BY AND ORGANIZED PURSUANT TO THE
- 11 MICHIGAN CAMPAIGN FINANCE ACT, ACT NO. 388 OF THE PUBLIC ACTS OF
- 12 1976, BEING SECTIONS 169.201 TO 169.282 OF THE MICHIGAN COMPILED
- 13 LAWS, SHALL COMPLY WITH SECTION 41 OF ACT NO. 388 OF THE PUBLIC
- 14 ACTS OF 1976, BEING SECTION 169.241 OF THE MICHIGAN COMPILED
- 15 LAWS, WHICH IMPOSES CERTAIN REQUIREMENTS ON THE ACCEPTANCE OF
- 16 CASH CONTRIBUTIONS AND REQUIRES THAT THE COMMITTEES CITED IN THIS
- 17 SECTION MAINTAIN RECORDS THAT WILL ENABLE THEM TO DISCLOSE CER-
- 18 TAIN INFORMATION ABOUT EACH PERSON WHOSE TOTAL CONTRIBUTION
- 19 EXCEEDS \$20.00.
- 20 Section 2. This amendatory act shall take effect April 1,
- 21 1995.
