



SENATE BILL No. 594

June 15, 1995, Introduced by Senators CISKY, GEAKE, BENNETT, HOFFMAN, GOUGEON, SHUGARS, DUNASKISS, STILLE, MCMANUS and PETERS and referred to the Committee on Families, Mental Health and Human Services.

A bill to amend section 2530 of Act No. 236 of the Public Acts of 1961, entitled as amended "Revised judicature act of 1961," as added by Act No. 297 of the Public Acts of 1982, being section 600.2530 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 2530 of Act No. 236 of the Public Acts
2 of 1961, as added by Act No. 297 of the Public Acts of 1982,
3 being section 600.2530 of the Michigan Compiled Laws, is amended
4 to read as follows:

5 Sec. 2530. (1) Except in any judicial circuit in which
6 employees serving in the circuit court are employees of the state
7 judicial council, the county treasurer shall deposit all fees
8 collected under ~~sections 2528(1)(f) and 2529(1)(f)~~ SECTION
9 2529(1)(D) AND COSTS COLLECTED UNDER SECTIONS 31, 32, AND 44 OF

1 THE SUPPORT AND VISITATION ENFORCEMENT ACT, ACT NO. 295 OF THE
2 PUBLIC ACTS OF 1982, BEING SECTIONS 552.631, 552.632, AND 552.644
3 OF THE MICHIGAN COMPILED LAWS, in a fund created for that purpose
4 to be known as the friend of the court fund. The county board of
5 commissioners shall appropriate all sums in this fund, and addi-
6 tionally shall annually appropriate from the county general fund
7 an amount not less than the total amount appropriated for the
8 office of the friend of the court in the county's last fiscal
9 year ending before ~~the effective date of this section~~ JULY 1,
10 1983, for the purpose of fulfilling the statutory obligations of
11 the friend of the court as provided in the friend of the court
12 act, ACT NO. 294 OF THE PUBLIC ACTS OF 1982, BEING SECTIONS
13 552.501 TO 552.535 OF THE MICHIGAN COMPILED LAWS, and ~~the sup-~~
14 ~~port and visitation enforcement act~~ ACT NO. 295 OF THE PUBLIC
15 ACTS OF 1982.

16 (2) In any judicial circuit in which employees serving in
17 the circuit court are employees of the state judicial council,
18 the county treasurer shall remit all sums collected under section
19 ~~2529(1)(f)~~ 2529(1)(D) AND COSTS COLLECTED UNDER SECTIONS 31,
20 32, AND 44 OF ACT NO. 295 OF THE PUBLIC ACTS OF 1982 to the
21 state, as provided in section 595(4). Pursuant to section
22 595(1), the legislature annually shall appropriate the amount
23 received under this subsection for the purpose of fulfilling the
24 statutory obligations of the friend of the court in the third
25 judicial circuit as provided in ~~the friend of the court act and~~
26 ~~the support and visitation enforcement act~~ ACT NO. 294 OF THE
27 PUBLIC ACTS OF 1982 AND ACT NO. 295 OF THE PUBLIC ACTS OF 1982.

1 Section 2. This amendatory act shall not take effect unless

3 of the 88th Legislature is enacted into law.
