

## **SENATE BILL No. 691**

September 27, 1995, Introduced by Senators BOUCHARD, BENNETT, STEIL, CARL, DE GROW and MC MANUS and referred to the Committee on Judiciary.

A bill to amend section 606 of Act No. 236 of the Public Acts of 1961, entitled as amended
"Revised judicature act of 1961,"

- 5 Sec. 606. (1) The circuit court has jurisdiction to hear
- 6 and determine a violation of section 83, 89, 91, 316, 317, 520b,
- 7 529, or 529a of the Michigan penal code, Act No. 328 of the
- 8 Public Acts of 1931, being sections 750.83, 750.89, 750.91,
- 9 750.316, 750.317, 750.520b, 750.529, and 750.529a of the Michigan

- 1 Compiled Laws, or section 7401(2)(a)(i) or 7403(2)(a)(i) of the
- 2 public health code, Act No. 368 of the Public Acts of 1978, being
- 3 sections 333.7401 and 333.7403 of the Michigan Compiled Laws,
- 4 SPECIFIED JUVENILE VIOLATION if committed by a juvenile 15 14
- 5 years of age or older and less than 17 years of age.

- 20 (D) SOLICITATION TO COMMIT A VIOLATION DESCRIBED IN SUBDIVI-
- 21 SION (A) OR (B).
- 22 (E) ANY LESSER INCLUDED OFFENSE OF A VIOLATION DESCRIBED IN
