

SENATE BILL No. 825

January 30, 1996, Introduced by Senator HOFFMAN and referred to the Committee on Local, Urban and State Affairs.

A bill to authorize the state administrative board to convey certain state owned property in Branch county; to prescribe conditions for the conveyance; and to provide for disposition of the revenue derived from the conveyance.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. The state administrative board, on behalf of the
- 2 state, may convey to the Branch intermediate school district, in
- 3 the county of Branch, for consideration of \$1.00, certain state
- 4 owned property now under the jurisdiction of the department of
- 5 military affairs and located in the city of Coldwater, Branch
- 6 county, Michigan, and further described as follows:
- 7 A parcel of land in the Northeast 1/4 of the Northwest 1/4
- 8 of Section 15, T6S, R6W, City of Coldwater, Branch County,
- 9 Michigan, more particularly described as follows:

- ! Commencing at the Northwest corner of the Northeast 1/4 of
- 2 the Northwest 1/4 of Section 15 (said point being the center line
- 3 intersection of State Street and Morse Setreet); thence East
- 4 500.0 feet along the North line of Section 15 (center line of
- 5 State Street); thence South 825.0 feet parallel with the West
- 6 line of the Northeast 1/4 of the Northwest 1/4 of Section 15;
- 7 thence West at right angle 500.0 more or less feet to the West
- 8 line of the Northeast 1/4 of the Northwest 1/4 of Section 15,
- 9 thence North along said West line of the Northeast 1/4 of the
- 10 Northwest 1/4 of Section 15 (center line of Morse Street) to the
- 11 point of beginning; containing 9.5 acres of land, more or less.
- 12 Sec. 2. The conveyance authorized by this act shall provide
- 13 that the property conveyed shall be used exclusively for public
- 14 purposes and that upon termination of that use, or upon use for
- 15 any other purpose, title to the property shall revert immediately
- 16 to the state, with the state assuming no liability for improve-
- 17 ments made at the grantee's expense.
- 18 Sec. 3. The conveyance authorized by this act shall be by
- 19 quitclaim deed approved by the attorney general and shall reserve
- 20 to the state all rights to coal, oil, gas, and other minerals,
- 21 excluding sand, gravel, clay, or other nonmetallic minerals found
- 22 on or under the property conveyed.
- 23 Sec. 4. The revenue received under this act shall be depos-
- 24 ited in the state treasury and credited to the general fund.
