

SENATE BILL No. 835

February 6, 1996, Introduced by Senators PETERS, ROGERS, DE BEAUSSAERT, CARL, NORTH, KOIVISTO and SCHWARZ and referred to the Committee on Education.

A bill to amend Act No. 154 of the Public Acts of 1995, entitled

"An act to make appropriations for the state institutions of higher education and certain state purposes related to education for the fiscal year ending September 30, 1996; to provide for the expenditures of those appropriations; and to prescribe the powers and duties of certain state departments, institutions, agencies, and officers,"

by adding section 207.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 154 of the Public Acts of 1995 is
- 2 amended by adding section 207 to read as follows:
- 3 SEC. 207. (1) FUNDS APPROPRIATED IN SECTION 101 FOR A
- 4 UNIVERSITY'S OPERATING BUDGET SHALL BE REDUCED BY 98% IF A
- 5 TUITION FEE THAT THE UNIVERSITY CHARGES TO ANY OF THE FOLLOWING
- 6 IS GREATER THAN THE TUITION FEE CHARGED TO A RESIDENT OF THIS
- 7 STATE:

- 1 (A) A PERSON WHO IS ASSIGNED TO DUTY IN THIS STATE AS AN
- 2 OFFICER, ENLISTED PERSON, SELECTEE, OR DRAFTEE OF THE ARMED
- 3 FORCES OF THE UNITED STATES.
- (B) A FORMER RESIDENT OF THIS STATE WHO BECOMES A RESIDENT
- 5 OF ANOTHER STATE OR A UNITED STATES TERRITORY SOLELY BECAUSE HE
- 6 OR SHE IS ASSIGNED TO DUTY IN THAT OTHER STATE OR A UNITED STATES
- 7 TERRITORY AS AN OFFICER, ENLISTED PERSON, SELECTEE, OR DRAFTEE OF
- 8 THE ARMED FORCES OF THE UNITED STATES.
- (C) THE SPOUSE OR CHILD OF A PERSON DESCRIBED IN SUBDIVISION
- 10 (A) OR (B).
- 11 (D) THE SPOUSE OR CHILD OF A PERSON DESCRIBED IN SUBDIVISION
- 12 (A) WHO CONTINUES TO RESIDE IN THIS STATE AFTER THE PERSON
- 13 DESCRIBED IN SUBDIVISION (A) IS ASSIGNED TO DUTY IN ANOTHER STATE
- 14 OR A UNITED STATES TERRITORY AS AN OFFICER, ENLISTED PERSON,
- 15 SELECTEE, OR DRAFTEE OF THE ARMED FORCES OF THE UNITED STATES.
- 16 (2) AS USED IN THIS SECTION:
- (A) "ARMED FORCES" MEANS ALL OF THE FOLLOWING: 17
- (i) THE ARMY, NAVY, AIR FORCE, MARINE CORPS, OR COAST 18
- 19 GUARD.
- 20 (ii) A RESERVE UNIT OF THE ARMY, NAVY, AIR FORCE, MARINE
- 21 CORPS, OR COAST GUARD.
- 22 (B) "TUITION FEE" MEANS THE AMOUNT CHARGED AN INDIVIDUAL TO
- 23 ATTEND A UNIVERSITY.
