

## **SENATE BILL No. 870**

February 15, 1996, Introduced by Senators ROGERS, BENNETT, GOUGEON and HOFFMAN and referred to the Committee on Judiciary.

A bill to amend Act No. 328 of the Public Acts of 1931, entitled as amended
"The Michigan penal code,"
as amended, being sections 750.1 to 750.568 of the Michigan

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 328 of the Public Acts of 1931, as
- 2 amended, being sections 750.1 to 750.568 of the Michigan Compiled
- 3 Laws, is amended by adding section 186a to read as follows:
- 4 SEC. 186A. (1) AN INDIVIDUAL WHO IS PLACED IN A JUVENILE
- 5 FACILITY AND WHO ESCAPES OR ATTEMPTS TO ESCAPE FROM THAT JUVENILE
- 6 FACILITY OR FROM THE CUSTODY OF AN EMPLOYEE OF THAT JUVENILE
- 7 FACILITY IS GUILTY OF A CRIME AS FOLLOWS:

Compiled Laws, by adding section 186a.

- 8 (A) IF THE INDIVIDUAL WAS PLACED IN THE JUVENILE FACILITY
- 9 FOR COMMITTING A VIOLATION THAT IF COMMITTED BY AN ADULT WOULD BE

- 1 A MISDEMEANOR. THE INDIVIDUAL IS GUILTY OF A FELONY PUNISHABLE BY
- 2 IMPRISONMENT FOR NOT MORE THAN 2 YEARS OR A FINE OF NOT MORE THAN
- 3 \$1,000.00, OR BOTH.
- (B) IF THE INDIVIDUAL WAS PLACED IN THE JUVENILE FACILITY
- 5 FOR COMMITTING A VIOLATION THAT IF COMMITTED BY AN ADULT WOULD BE
- 6 A FELONY, THE INDIVIDUAL IS GUILTY OF A FELONY PUNISHABLE BY
- 7 IMPRISONMENT FOR NOT MORE THAN 4 YEARS OR A FINE OF NOT MORE THAN
- 8 \$2,000.00, OR BOTH.
- (2) AS USED IN THIS SECTION: 9
- 10 (A) "ESCAPE" MEANS TO LEAVE WITHOUT LAWFUL AUTHORITY.
- (B) "JUVENILE FACILITY" MEANS A COUNTY FACILITY, AN INSTITU-11
- 12 TION OPERATED AS AN AGENCY OF THE COUNTY OR THE JUVENILE DIVISION
- 13 OF THE PROBATE COURT, OR A STATE INSTITUTION OR AGENCY DESCRIBED
- 14 IN THE YOUTH REHABILITATION SERVICES ACT, ACT NO. 150 OF THE
- 15 PUBLIC ACTS OF 1974, BEING SECTIONS 803.301 TO 803.309 OF THE
- 16 MICHIGAN COMPILED LAWS, TO WHICH THE INDIVIDUAL HAS BEEN COMMIT-
- 17 TED UNDER SECTION 18(1)(E) OF CHAPTER XIIA OF ACT NO. 288 OF THE
- 18 PUBLIC ACTS OF 1939, BEING SECTION 712A.18 OF THE MICHIGAN
- 19 COMPILED LAWS, OR UNDER SECTION 27A OF CHAPTER IV OR SECTION 1 OF
- 20 CHAPTER IX OF THE CODE OF CRIMINAL PROCEDURE, ACT NO. 175 OF THE
- 21 PUBLIC ACTS OF 1927, BEING SECTIONS 764.27A AND 769.1 OF THE
- 22 MICHIGAN COMPILED LAWS.
